- Amondment to the Note and \* The Note and S \* is hereby amended as follows:
  - (a) The principal amount wherever said amount is expressed therein, is hereby amended to provide: ONE HUNDRED NINETY TWO THOUSAND and 00/100 (\$192,000.00) DOLLARS.
  - (b) The interest rate of the Note wherever said amount is expressed therein, is hereby amended to provide: TWO (2%) percent above the Prime Commercial Rate of Interest charged from time to time by the Bank except that the rate shall be FOUR percent (4%) above the Prime Commercial Rate of Interest charged from time to time by the Bank after maturity. Minimum interest charged will be EIGHT (8%) percent per annum.

- (c) A monthly payment of THREE THOUSAND FIVE HUNDRED and no/100. (\$3,500.00) Dollars principal and interest due will be payable at the rate specified each and every month for FIFTY-NINE (59) consecutive months commencing JULY 4, 1993 monthly with a final payment of the entire outstanding principal balance plus any accrued interest due if not sooner paid, shall be due and payable on JUNE 4, 1998
- (d) The Maturity Date of the Note and \* is extended to JUNA 4, 1998.
- (e) If any payment of the principal and interest of the unpaid principal balance due under this note becomes overdue for a period of three (3) days, the maker shall pay FIVE (5) per cent of the amount of the the payments due or \$15.00, whichever is higher, and payments of principal and interest past due for thirty (30) days shall bear an interest at the rate of prime plus FOUR (4) per cent per annum until paid. This change will defray part of the increased costs of collection resulting from such late payment.
