DECLARATION OF CONDOMINIUM OWNER AND BY LAWS EASEMENT, RESTRICTIONS, AND COVENANTS FOR THE 150 PARK AVE. CONDOMINIUM ASSOCIATION

WHEREAS, PARK OF RIVER OAK HOMEOWNERS ASSOCIATION,

We, the undersigned, representing two-thirds (2/3) of the Units at the Park of River Oaks Homeowners Association, in accordance with the provisions of Article IX, Section 1 of the Declaration of Covenants, Conditions, Restrictions and Easements for the Park of River Oaks Homeowners Association, do hereby vote to amend the Declaration by deleting Article III, Section 1 and replacing it with the following:

ARTICLE III

BOARD OF DIRECTORS

1. Method of Election. The direction and administration of each residential condominium association constructed on The Properties shall, as long as each such building is subject to the Act, be vested in a Board of Managers. Each such Board of Managers shall appoint one of its Members for each 100 Units or fraction thereof in their building to serve as a director on the Board of Directors (the "Board") of the Association, and the Board shall consist of the aforesaid Directors from each Condominium Association. All matters decided by the Board shall be by vote as provided herein and in the By-Laws of the Association. Any vacancy to be filled by reason of an increase in the number of Directors, shall be filled by the respective Association's Board of Managers for a term to expire at the next annual meeting of the respective Condominium Association. All Board Members shall serve for a one-year term, except in the event of a vacancy caused by an increase in the number of Directors, as set forth above.

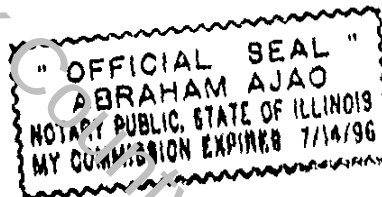
