



1. CONDITIONAL FUCHT TO REFINANCE

At the maturity due of the Note and Security Instrument (the "Maturity Date"), I will be able to obtain a new loan w Loan") with a new hattrity Date of June 1, 20, 23, and with an ("New Loan") with a new haturity Date of interest rate equal to the "New Note Rate" determined in accordance with Section 3 below if all the conditions provided in Sections 2 and 5 below are met (the "Conditional Refinancing Option"). If those conditions are not met, I understand that the Note Holder is under no obligation to relinance or modify the Note, or to extend the Maturity Date, and that I will have to repay the Note from my own resor ces or find a lender willing to lend me the money to repay the Note.

2. CONDITIONS TO OPTION

If I want to exercise the Conditional Reginancing Option at maturity, certain conditions must be met as of the Maturity Date.
