WHEREAS FIRST FEDERAL BANK FOR SAVINGS, FORMERLY KNOWN AS. FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF DES PLAINES ("Lender"), whose address is 749 Lee Street, Des Plaines, IL, loaned to Joel R. Forpanek, 1131 Gulf Keys Rd., Elgin, IL 60120 ("Borrower" and collectively known as "Parties") the sum of One hundred eighteen thousand and 00/100 Dollars (\$118,000.00), secured by the real estate described in Exhibit A attached and made a part hereof, and evidenced by a Note and Mortgage executed and delivered on, September 20, 1991, which mortgage was duly recorded on September 24, 1991 as Document Number 91434142, in the Office of the Cook County Recorder of Deeds, and which Note and Mortgage are hereby incorporated herein as a part of this instrument, and;

WHERE 3, the Borrower has requested that certain modifications be made in the Note and Mortgage, and;

WHEREAS, Enrower represents to Lender that there are no encumbrances evidencing other indebtedness other subsequent liens (second mortgages) now outstanding against the mortgaged premises, except those hold by Lender, and the lien of the Lender's Mortgage, as modified, is a valid lien, and;

WHEREAS, the Borrower has requested certain modifications of the said Note and Mortgage: THEREFORE, for good and valuable consideration, the parties do mutually agree that the Note and Mortgage are modified as follows:

Interest Rate: The interest rate of the Note is changed to 6.75% per annum, said rate change to take effect on the 1st day of Jurie 1993. This rate shall remain fixed throughout the remaining term of the loan.

Principal Balance: The unpaid balance of the ricle including any financed points is One hundred fourteen thousand seventy one and 68/100 Douces (\$114.071.68). In consideration of this foan modification agreement, discount points in the surrent of \$3.053.01 were paid.

Maturity Date: The maturity date of the note is not mydified by this agreement. The maturity date is October 1, 2006.

Principal & Interest Payment: Borrower agrees to pay principal halance with interest at the above stated rate in monthly payments of One thousand eighty three rate 13/100 Dollars (\$1,083.13).

Payment Due Date. The above payment amount shall be due monthly beginning on the 1st day of July 1, 1993 and on the 1st of each month thereafter un if above Note is fully paid, but no later than October 1, 2006.

Borrower covenants and agrees to pay the balance of the indebtedness evidenced by the Note and secured by the Mortgage as modified, and to perform the covenants contained in the Mortgage. Borrower further agrees that the prepayment privilege now in effect shall remain in full force and effect. Borrower represents to Lender that there is no second mortgage or other subsequent lien now obstanding against the Mortgaged Premises held by the Lender, except as otherwise disclosed in this Agreement, and that the lien of the Mortgage is a valid, first and subsisting lien on the Mortgaged Premises.

The parties acknowledge and agree that no liability whatspever is admitted on the part of any party, except Borrower's indebtedness to Lender under the Note and Mortgage, and that all agreements and understandings between Borrower and Lender are expressed and embodied in the Note and Mortgage, as modified by this Agreement.
