MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on MARCH 16 1990. The mortgagor is HURDLE G. ANDERSON, UNMARRIED (Borrower). This Security Instrument is given to VERSATILE SECURITY, which is organized and existing under the laws of ILLINOIS, and whose address is 1400 S. WOLF ROAD, WHEELING, ILL. 60090 ("Lender").
