AMENDED ORIGINAL CONTRACTOR'S CLAIM FOR LIEN

That on October 8, 1990, the claimant made a contract with said owner to furnish general contractor services, materials and labor for the construction of an addition and alterations for the building erected on said land for the sum of \$241,722.00 and on November 29, 1991, completed thereunder the furnishing of labor and materials to the value of \$233,722.00.

That at the special instance and request of said owner, the claimant furnished extra and additional materials and extra and additional labor for said premises to the value of \$21,063.00 and completed same on November 26, 1991.

That said owner is entitled to credits on account thereof as follows, to wit: \$230,561.00; leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of \$24,224.00, for which, with interest, the claimant claims a lien on said land and improvements.




