## ASSIGNMENT OF MORTGAGE

On November 20, 1992 Irving Federal Bank for Savings was selected by the Office of the Thrift Supervision ("OTS") pursuant to Section 5(d)(2)(A) of the Home Owners Loan Act of 1933, as amended by Section 31 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"). OTS, pursuant to order number 92-494 appointed the Resolution Trust Corporation ("RTC") as Receiver of Irving Federal Bank for Savings.

On November 20, 1992 the RTC by order number 92-494 chartered Irving Federal Bank for Savings, F.S.B., as a federal mutual savings bank, and pursuant to section 5(d)(2)(B)(f) of FIRREA, appointed the RTC as Conservator for Irving Federal Bank for Savings, F.S.B.

FOR VALUE RECEIVED, the undersigned, RESOLUTION TRUST CORPORATION, as Conservator of IRVING FEDERAL BANK FOR SAVINGS, F.S.B. successor in interest to Irving Federal Bank for Savings, formerly Irving Federal Savings and Loan Association having a mailing address of 3515 W. Irving Park Road, Chicago, Illinois 60618, has created, bargained, sold, alienated, transferred and set over, and by these presents does grant, bargain, sell, assign, transfer and set over unto Lafayette National Bank, P.O. its successors and assigns, a certain Indenture of mortgage dated the 11TH day of SEPTEMBER, 1976 made by--WILLIAM WOLF, DIVORCED AND NOT SINCE REMARRIED




