EXHIBIT B

Restrictive covenants to be incorporated in the Trustee's Deed:

Grantee, on behalf of itself, and on behalf of its successors and assigns, agrees that:

- 1. Grantee's building on the real estate subject to this instrument may not exceed nine thousand one hundred (9,100) square feet.
- 2. The rest estate subject to this instrument shall not be used as a movie theatre, ice cream shop, popcorn shop, or candy store for so long as the adjoining to the East real estate is subject to a Lease dated April 23, 1987 with Landing Theatres, Inc. as original Lessee.

Grantor. on behalf of itself, and on behalf of its successors and assigns, acrees that for a period of five (5) years from the date of this instrument, it shall not lease, sublease or otherwise operate or contract, by conveyance or otherwise, on premises owned or leased by Grantor within two (2) miles of the real estate subject to this instrument, for a food service establishment featuring or specializing in the sale, at retail, of italian food in a manner similar to Grantee. Featuring or specializing, for the purpose of this provision, shall mean that such items, as aforedescribed shall be identifiable as major menu items in terms of sales volume or public identification. The aforesaid restriction shall not be applicable to any purveyor of unprepared foods intended for future, off-precises consumption.
