

## THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON PAGE 1 (THE REVERSE SIDE OF THIS TRUST DEED):

- 1. Grantors shall (1) promptly repair, restore or rebuild any buildings or improvements now or bereafter on the premises which may become damaged or be destroted, (2) keep earl premises in good condition and repair, without waste, and free from inechanic's or other links or claims for here not expressly subsidinated to the hereof, (2) pay when due any indebtedness which may be secured by a lies or charge an the premises appeared to the him hereof, and upon request exhibit satisfactory evidence of the disc harge of such prior bent of Trustee or to Beneficiary, (4) complete within a reasonable time any buildings one or at any inner in process of erection upon said premises.
