The form of all policies and renewals must be acceptable to (ender, Lender will have the right to hold the policies and renewals if Lender requires, I will promptly give Lender all receipts of peld premiums and renewal notices that I receive.

If I obtain earthquike insurance, any other hazard insurance, credit life and/or disability insurance, or any other insurance on or relating to the Property or the Secured Notes and which are not specifically required by Lender, I will name Lender as loss payer of any proceeds.

If there is a loss or demand to the Property, I will promptly notify the proper insurance company and Lender, if I do not promptly prove to the insurance company that the loss or demand occurred, then Lender may do so,

The amount paid by the insurance company is called "Proceeds." 6. BORROWER'S OBLIGATION TO MAINTAIN THE PROPERTY AND TO FULFILL ANY LEASE OBLIGATIONS

I will keep the Property In good repair. I will not destroy or substantially change the Property and I will not allow the Property to deteriorate, I will keep and maintain the Property in compliance with any atete or federal hazardous materials and hazardous waste laws. 12. MAXIMUM LOAN OHARGES

14. NOTICES REQUIRED UNDER THIS SECURITY INSTRUMENT

15. GOVERNING LAW: SEVERABILITY

This Sacurity instrument and the Secured Flotes shall be governed by and construed under federal law and federal rules and regulations including those for federal savings and loan associations, called "Federal Law," in the event that any of the terms or provisions of this Security Instrument or the Secured Notes are interpreted or construed by a court of compatent jurisdiction to be void, invalid or unenforceing, such decision shall affect only those provisions an construed or interpreted and shall not office the remaining provisions of this Security Instrument or the Secured Notes.

16. BORROWER'S COPY

I acknowledge the receipt of one conformed copy of the Secured Notes and of this Security Instrument.

17. LENDER'S RIGHTS TO RENTAL PAYMENTS AND TO TAKE POSSESSION OF THE PROPERTY

If Lender requires immediate payment in full or if I ebandon the Property, then Lender, Persons authorized by Lender, or a receiver appointed by a court at Lender's request may: (A) collect the rental payments, including overdue rental payments, directly from the tenants; (B), enter upon and take possession of the Property; (C) manage the Property; and (D) sign, cancel and change rental agreements and leases. If Lender notifies the tenants that Lender has the right to collect rental payments directly from them under this Paragraph. 17, I agree that the tenants may make those rental payments to Lender without having to ask (i) Lender whether I have falled to keep my promises and agreements under this Security instrument, or (ii) me for my permission to do so.

LOST, STOLEN OR MUTILATED DOCUMENTS

If any of the Loan Documents are lost, stolen, mullisted or destroyed and Lander delivers to me an inversification in my favor, signed by Lender, then I will sign and deliver to Lender a Loan Document identical in form and content which will have the effect of the original for all purposes.

WAIVER OF STATUTE OF LIMITATIONS

I will waive, within applicable law, the pleading of the statute of limitations as a defense to enforce this Securily instrument, including any obligations referred to in this Security Instrument or Secured Notes

CAPTIONS

The captions and headings a beginning of each paragraph of this Security Instrument are for reference only and will not be used in the interpretation of any provision of this Security Instrument.

MODIFICATION

This Security instrument may be modified or emended only by an agreement in writing signed by Borrower and Lendor,
