MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on APRIL 18, 1989. The mortgagors HERMAN HUGHES, JR. & LUCINDA HUGHES, HIS WIFE (J) STEELE & LUBER ("Borrower").
