other described instruments, and does hereby release, quitclaim and
convey unto HENRY A MARTA AND HELEN M MARTA, HIS WIFE AS JOINT
TENANTS AND THEIR heirs, successors, legal representatives and
assigns, whatever right, title, interest, claim or demand the Bank
may have acquired in, through or by said Trust Deed and the other
described instruments to the said property.
