MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE IS DATED MAY 25, 1993, BETWEEN MICHAEL J. WASSERMAN and SALLY J. MORTGAGE. Grantor and Lender have entered into a mortgage dated March 23, 1992 (the "Mortgage") recorded in COOK County, State of Illinois as follows:

RECORDED MARCH 27, 1992, AS DOCUMENT NO. 92204612, EXECUTED BY MICHAEL J. WASSERMAN, AND SALLY J. WASSERMAN, HIS WIFE AND GIVEN TO BRICKYARD BANK TO SECURE A NOTE IN THE AMOUNT OF \$459,000.00.

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property (the "Real Property") located in COOK County, State of Illinois:

BORROWER HAS RECEIVED AN ADDITIONAL LOAN IN THE PRINCIPAL AMOUNT OF \$94,000.00. SAID ADDITIONAL LOAN IS EVIDENCED BY A SEPERATE CHANGE IN TERMS AGREEMENT (AGREEMENT) DATED MAY 25, 1993. SAID NOTE IS SECURED BY THE PROPERTY PURSUANT TO THE TERMS OF THE MORTGAGE..

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). It is the intention of Lender to retain as liable all parties to the Mortgage and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
