### CONDOMINIUM RIDER

THIS CONDOMINIUM RIDER is made this 14TH day of JUNE

, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed 1993 of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to

AAA HOME FINANCE CORP.

(the "Lender") of the same date and covering the Property described in the Security Instrument and located at:

(Property Address)

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: GRANVILLE COURT CONDOMINIUM

(Name of CondosInium Project)

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds 7.1d benefits of Borrower's interest.

CONDOMIN'IUM COVENANTS. In addition to the covenants and agreements made in the Security

Instrument, Borrower and Lander further covenant and agree as follows:

C. PUBLIC LIABILITY INSURANCE. Borrower shall telle such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy acceptable in form, amount,

and extent of coverage to Lender.

D. CONDEMNATION. The proceeds of any award or claim for damages, direct or consequential, payable to Borrower in connection with any condemnation or giver taking of all or any part of the Property, whether of the unit or of the common elements, to for any conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender. Such proceeds shall be applied by Lender to the sums secured by the Security Instrument as provided in Uniform Covenant 10.

E. LENDER'S PRIOR CONSENT. Borrower shall not, except after notice to Lender and with Lender's

prior written consent, either partition or subdivide the Property or consent to:
