THE COURT FINDS:

1. That this Court has jurisdiction of the subject matter and of the parties to this action.
2. That on the 23rd day of July 1991 pursuant to Judgment, Petitioner duly purchased the parcel of real estate described in the petition heretofore filed and that Petitioner remains the holder of the certificate representing said purchase.
3. That said Certificate of Purchase is numbered F46196.
4. That the time for redemption from said sale has expired and the parcel described in said petition has not been redeemed from said sale.
5. That all taxes and special assessments, if any, which became due and payable subsequent to said sale have been paid, cancelled or redeemed, and all forfeitures or tax sales which occurred subsequent to said sale have been cancelled or redeemed, and that proof of the payment, cancellation or redemption of all subsequent forfeitures or tax sales or taxes have been submitted in open Court and the Court has examined the same, and the proofs are attached to the transcript ordered as a part of the record herein.
6. That the notices required by law have been given, that due diligence has been used in locating and serving the parties in interest, and that petitioner has fully complied with all the provisions of law entitling it to a Tax Deed to said parcel of real estate.
