LEGAL DESCRIPTION

Lot 26 in Yale's Subdivision of Block 45 in Elston's Addition to Chicago in the NE 1/4 of Section 5, Township 39 North, Range 14 East of the Third Principal Meridian (excepting that part of Lot 26, described as follows: Beginning at the most southerly corner of said Lot on Kingsbury Street and running thence Northwesterly along the lot line 15 feet; running thence Northeasterly along a line drawn parallel to the lot line between Lots 26 and 27 to the alley; thence Southeasterly along said alley to the most southerly corner of said Lot 26 or said alley; thence Southwesterly along lot line to the place of beginning).
