16. Borrower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.

17. Transfer of the Property or a Beneficial Interest in Borrower, if all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument. BALLOON RIDER (CONDITIONAL RIGHT TO REFINANCE)

THIS BALLOON RIDER is made this 17TH day of JUNE , 1983 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Deed to Secure Debt (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure the Borrower's Note to SEARS MORIGAGE CORPORATION. The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note, Security Instrument and this Rider. The Lender or anyone vao takes the Note, the Security Instrument and this Rider by transfer and who is entitled to receive payments under the Note is called the "Note Folder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, By rower and Londer further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

1. CONDITIONAL RIGHT TO REFINANCE

At the maturity det of the Note and Security Instrument (the "Note Maturity Date"), I will be able to obtain a new loan ("New Loa") with a new Maturity Date of JULY 1, 2023. (the "New Maturity Date") and with an interest rate equal to the "New Loan Rate" determined in accordance with Section 3 below? exercise the Conditional Refinance Option by notifying the Note Holder no earlier than 60 calendar days and no later than 45 calendar days prior to the Note Maturity Date.
