CLAIM FOR LIEN FOR DEMOLITION

The claimant, CITY OF CHICAGO, a Municipal Corporation, in the County of Cook, State of Illinois, by virtue and authority granted by Chapter 24, Section 11-31-1, hereby files its claim for lien against the following described property, to wit:

Parcel of land comprised of all of Lot 3 and of Lot 4, except the West 12.00 feet of the North 103.25 feet of said Lot 4, also all of each of Lots 17 and 21 including those portions of said Lots heretofore dedicated for alleys, but now vacated; also that part of vacated alley, 16 feet wide, lying South of and adjoining the South line of said Lots 3 and 4, and lying South of and adjoining the South line of said Lots 17, 18 and 19 and lying between a straight line which extends Southwardly from the South East corner of said Lot 3 to the North East corner of said Lot 19, and a straight line which extends Southwestwardly from the South West corner of said Lot 4 to a point on the North line of said Lot 17 which is 22.76 feet, measured along said North line, East from the North West corner of said Lot 17; all in Block 1 in Snow and Dickinson's Subdivision of Blocks 1, 2 and 3 in William Hale Thompson's Addition to Chicago in the North West 1/4 of Section 23, Township 38 North, Range 14, East of the Third Principal Meridian; and comprised also that part of vacated East 63rd Place, (being a strip of land 5 feet wide lying South of and adjoining the South lines said Lots 17 and 18 and of Lots 19, 20 and 21 and the West line extended South of said Lot 17, all in Block 1 aforesaid in Cook County, Illinois, commonly known as 855 East 63rd Street, Chicago, Illinois.
