Any deficiency in the amount of any such aggregate monthly payment shall, unless made good prior to the due date of the next payment, constitute an event of default under this Mortgage. At Mortgagee's option, Mortgager will pay a "late charge" not exceeding four per centum (4%) of any installment when paid more than fifteen (15) days after the due date thereof to cover the extra expense involved in handling delinquent payments, but such "late charge" shall not be payable out of the proceeds of any sale made to satisfy the indebtedness secured hereby, unless such proceeds are sufficient to discharge the entire indebtedness and all proper costs and expenses secured hereby.

#### VA ASSUMPTION POLICY RIDER

#### NOTICE: THIS LOAN IS NOT ASSUMABLE WITHOUT THE APPROVAL OF THE DEPARTMENT OF VETERANS AFFAIRS OR ITS AUTHORIZED AGENT.

THIS ASSUMPTION POLICY RIDER is made this 27TH day of OCTOBER , 19 92 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Deed to Secure Debt ("Instrument") of the same date herewith, given by the undersigned ("Mortgager") to secure the Mortgager's Note ("Note") of the same date to PLATTE VALLEY MORTGAGE CORPORATION, A NEBRASKA CORPORATION

assigns ("Mortgagee") and covering the property described in the Instrument and located at:

Notwithstanding anything to the contrary set forth in the Instrument, Mortgagoe and Mortgagor hereby acknowledges and agrees to the following:

GUARANTY: Should the Department of Veterans Affairs fail or refuse to issue its guaranty in full amount within 60 days from the date that this loan would normally become eligible for such guaranty committed upon by the Department of Veterans Affairs under the provisions of Tale 38 of the U.S. Code "Veterans Benefits", the Mortgagee may declare the indebtednoss hereby secured at once due and payable and may forcelose immediately or may exercise any other rights hereunder or take any other proper action as by tay provided.

TRANSFER OF THE PROPERTY: This loan may be clared immediately due and payable upon transfer of the property securing such loan to any transferce, unless the acceptability of the assumption of this loan is established pursuant to section 1814 of Chapter 37, Title 38, United States Code.

An authorized transfer ("assumption") of the property shall also be subject to additional covenants and agreements as set forth below:

- (a) ASSUMPTION FUNDING FEE: A fee equal to one-half of 1 percent (50%) of the balance of this loan as of the date of transfer of the property shall be payable at the time of transfer to the logarithms holder or its authorized agent, as trustee for the Department of Veterans Affairs. If the assumer fails to pay this fee at the simple of transfer, the fee shall constitute an additional debt to that already secured by this instrument, shall be a fator at the rate herein provided, and, at the option of the payee of the indebtedness hereby secured or any transferor thereof shall be immediately due and payable. This fee is automatically waived if the assumer is exempt under the provisions of 38 [1.2.C. 1829 (b).
- (b) ASSUMPTION PROCESSING CHARGE: Upon application for approval to allow assumption of this loan, a processing fee may be charged by the loan holder or its authorized agent for determining the credity orthiness of the assumer affigures subsequently revising the holder's ownership records when an approved transfer is completed. The amount of this charge shall not exceed the maximum established by the Department of Veterans Affairs for a loan to which section 1814 of Chapter 37, Title 38, United States Code applies.
- (c) ASSUMPTION INDEMNITY LIABILITY: If this obligation is assumed, then the assumer hereby agries to assume all of the obligations of the veteran under the terms of the instruments creating and securing the loan, including 'no obligation,' of the veteran to indemnify the Department of Veterans Affairs to the extent of any claim payment arising from the guaranty or insurance of the indebtedness created by this instrument.
