AND, IT IS FURTHER ORDERED that Corinne Daugherty ~~his/her/his~~ heirs, agents, successors and assigns be and are permanently enjoined and restrained from renting, leasing, using or occupying the subject premises.

The Court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction.

AND, IT IS FURTHER ORDERED that this cause is hereby disposed of subject to the above permanent injunction and the above lien and personal judgment(s) against the named defendant(s) in the aforesaid amount(s). In addition, it is disposed subject to the \$ 1,812.50 receiver certificate entered on 5/13/90.

This order is final and appealable, the Court finding no just cause or reason to delay its enforcement or appeal.
