WAIVER AND SUBORDINATION OF MECRANIC'S LINE

WHEREAS, Manager has performed, is currently performing and may perform in the future, various services as a property manager on behalf of Owner and/or Owner's agent Reanuke Associates, Ltd.;

WHEREAS, Manager has agreed to execute and deliver this Agreement to induce ARC to enter into a certain Loan Modification Agreement with Owner dated as of December 31, 1992,

NOW, THEREFORE, in consideration of the foregoing recitals and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, MANAGER HEFFEY IRREVOCABLY AGREES AS FOLLOWS:

Manager does hereby fully and completely waive and release, for it, its agents, representatives, successors and assigns, and for all its agents or subcontractors and their respective agents or subcontractors, and all of the heirs, personal representatives, successors and assigns of any such agents or subcontractors, any and all mechanics liens and other liens and all claim of, or right to, any mechanic's lien or other lien, now existing, under the common laws and statutes of the State of Illinois, against, or with respect to, the Property or any part thereof, or any improvement constructed thereon, or with respect to the estate or interest of any person whatsoever in the Property or such improvements, or any part thereof, or with respect to any services, material, fixtures, apparatus, or machinery furnished to the Property, or with respect to any

moneys or other consideration which may now be due to Manager, which claim of lien might be asserted by reason of the doing, making or furnishing heretofore, by Manager, its successors, assigns, materialmen, agents, or subcontractors of any labor, services, material, fixtures, apparatus, machinery, improvements, repairs or alterations in connection with the Property or any improvements thereon.

- Manager hereby subordinates to the Mortgage and any other documents securing the Loan, for it, its agents, representatives, successors and assigns, and for all its agents or subcontractors and their respective agents or subcontractors, and all of the heirs, personal representatives, successors and assigns of any such agents or subcontractors, any and all mechanics lies, and other liens and all claim of, or right to, any mechanic's lien or other lien, hereafter acquired, under the common laws and statutes of the State of Illinois, against, or with respect to, the Property or any part thereof, or any improvement constructed thereon, or with respect to the estate or interest of any person vistsoever in the Property or such improvements, or any part thereof, or with respect to any services, material, fixtures, apparatus, or machinery to be furnished to the Property at eny time in the future, or With respect to any moneys or other consideration which may hereafter be due to Manager, which claim of lien might be asserted by reason of the doing, making or furnishing at any time hereafter, by Manager, it's successors, assigns, materialmen, agents, or subcontractors of any labor, services, material, fixtures, apparatus, machinery, improvements, regains or alterations in connection with the Property or any improvements thereon.
- 3. Manager further agrees that the effect of this Agreement and the waiver and subordination made herein shall not be impaired, affected or diminished by the production, from time to time, of written waivers of liens, or by any other actions apparently inconsistent herewith.
- A. Manager hereby waives and agrees not to bring, er assist in bringing, any claim, action, cause of action or proceeding regarding or in any way related to this Agreement or the waiver or subordination contained herein and Manager further agrees that this Agreement is, will constitute, and may be pleaded as, a bar to any such claim, action, cause of action or proceeding.
- 5. To give statutory notice of the waiver, subordination and other provisions contained herein, this Agreement shall be filed in the Office of the Recorder of Deeds of Cook County, Illinois.
