THE COVENANTS, CONDITIONS AND PROVISIONS REFERRED TO ON THE REVERSE SIDE OF THIS TRUST DEED:

- 1. Mirigagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or herrafter on the premises which may become damaged or be destroyed; (2) keep said promises in good condition and repair, without waste, and free from mechanics or other bens or claims for then not expressly subordinated to the lien hereof, (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactors evidence of the discharge of such prior lien to Trustee or to holders of the note. (4) complete within a reasonable time any building or buildings now or at any time in process of erection spon and premises. (5) comply with all requirements of law or municipal ordinances with respect to the premises and the use thereof, (6) make no material alterations in said premises except as required by law or municipal ordinance.
- 2. Mortgagors shall pay before any penalty stacches all general taxes, and shall pay apersal sasessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, turnish to Trustee or to holders of the note duplicate receipts therefor. In prevent of shall hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.
- 3. Margegors shall heep all husldings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning or windstorm under policies providing for payment by the insurance compenses of moneys sufficient either to pay in the control to the holders of the note, under insurance policies passible in case of loss or damage, to Trustee for the benefit of the holders of the note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and cenewal policies to the note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.
- 4. In case of default therein, Trustee of the holders of the note may, but need not, make any partners or perform any act hereinbefore required of Mortgagors in any form and manner decided expedient, and may, but need not, make full or partial payments of principal of interest on prior encumfrances, if any, and purchase, discharge, compromise or settle any last lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeither affecting taid premies or contest any tax or assessment. All moneys paid for any of the purposes berein authorized and all expenses paid or incurred in connection therein, including attorners' ters, and any other moneys advanced by Trustee or the holders of the note to protect the mortgaged promises and the lien hereof, plus reasonable compensation to Trustee for each matter conterring which action herein authorized may be taken, shall be so much additional indebtedness ascured hereby and shall become immediately due and parable without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the note shall never be considered as a waiver of any right according to them on account of any default hereunder on the part of Mortgagors.
- 5. The Trustee or the bottom of the note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.
- 6. Mortgagors shall pay such it. of indulatedness berein mentioned, both principal and interest, when due according to the terms hereof. At the option of the holders of the note, and without notice to Mortgagors, all unpaid deb induces accured by this Trust Beed shall, notwithstanding anything in the note or in this Trust Beed to the contrary, become due and payable (a) immediately in the case of default in making payors to day installment on the note, or (b) when default shall occur and continue for three days in the performance of any other agreement of the Mortgagors berein contained.
- 7. When the indelitedness basely secured shall become due whether by acceleration or otherwise, holders of the note or Trustee shall have the right to foreclose the lien hereof, there shall be allowed an included as additional indelitedness in the decree for sale all expenitures and expenses which may be paid or incurred by or on behalf of Trustee or holders of the note for attorners' lees. The proceeds of any foreclosure sale of the premiers shall be distribute (as explied in the following order of priority first, on account of all costs and expenses incident to the furnishing proceedings, including all such items as are mentioned in the preceding paragraph incred; second, all other stems which under the terms hereof constitute secured indobtedness additional to that evidenced by the note, with interest thereon as herein provided, third, all principal and interest remaining unpoid on the note, fourth, any overplus to Mortgagors, their heirs, legal representatives or assigns, as their rights may appear.
- 9. Upon, or at any time after the filing of a tall to foreclose this trust deed, the court in which such hill is filed may appoint a receiver of said premises. - 13. Trustee shall release this trust deed and the hen thereof by proper instrument upon presentation of satisfactory evidence that all indebter area is used by this trust deed has been fully paid, and Trustee may execute and deliver a release hereof to and at the request of any ferson who shall, either before or after maturity chereof, pinder or healthis to Trustee the note, representing that all indebterdness hereby occurred has been paid, which represents in Trustee may accept as true without inquiry.
