WHEREAS, COMCORDIA FEDERAL DANK FOR SAVENGS, Lansing, Tilinois ("Association") was formally a federally-chartered savings association, the accounts of which were insured by the Federal Deposit Insurance Corporation ("FDIC");

MERRIAS, pursuant to Section 5(d)(1)(B)(1) of the Home Owner's Loan Act of 1933 ("HOLA") as amended by Section 201 of the Financial Institution's Reform, Recovery and Enforcement Act of 1969 ("FIRREA"), The Office of Tarift Supervision of the Department of the Treasury ("OTS") may, without any requirement of notice, hearing or other action, appoint a conservator or receiver of a federally-coartered savings association;
