SPECIAL LIMITED IRREVOCABLE POWER OF ATTORNEY

Knowthat FULL SERVICE MORTGAGE CORP. (corporation/partnership/sole proprietorship) with its principal offices at 1150 W. Diversey, Chicago, IL 60614 ("Principal"), does hereby make, constitute and appoint WESAV Mortgage Corporation, an Arizona corporation with offices at 9060 E. If prior to the exercise of the power hereby conferred upon WESAV, Principal shall have become bankrupt, dissolved, liquidated, disabled, incapacitated, or have died, and WESAV shall have thereafter exercised such power, Principal hereby declares any such acts performed by WESAV pursuant to this power binding and effective in the same manner that they would have been had such bankruptcy, dissolution, liquidation, disability, in appoint or death of Principal not have occurred.
