This Quitelaim Deed is made and executed upon, and is subject to the following express conditions and covenants, said conditions and covenants being a part of the consideration for the Property hereby conveyed and are to be taken and construed as running with the land:

FIRST: The Property shall be used solely for the purposes of low and moderate income housing as defined by the Department of Housing and Urban Development for a period of less than fifteen (15) years from the date of this Quitclaim Deed. If the Grantee breache covenant, the Grantor may re-enter the Property and revest title in the City of Chicago. covenant shall terminate fifteen (15) years from the date of this Quitclaim Deed.

SECOND: The Grant shall rehabilitate, redevelop or improve the Property in accordance with the plans and specifications set forth in the application heretofore submitted by the Grantee to the Department of Housing of the City of Chicago ("Project"). If the Grantee breaches this covenant, the Grantor may re-enter the Property and revest title in the City of Chicago. This covenant shall terminate upon the issuance of a Cortificate of Completion by the Grantor. The Certificate of Completion shall be in a recordable form and shall constitute a conclusive determination that the Project has been completed to the satisfaction of the Grantor.

THIRD: The Grantee shall complete the Project no later than twenty-four (24) months from the date of this Quitclaim Deed. If the Grantee breaches this covenant, the Granter may re-enter the Property and revest title in the City of Chicago. This covenant shall terminate upon the issuance of a Certificate of Completion by the Grantor.

FOURTH: The Grantee shall not sell, convey or assign the Property or any part thereof or any interest therein without the prior written approval of the Grantor, except that the Grantee may mortgage the Property or make a collateral assignment of a beneficial interest for the

purpose of financing the Project. If the Grantee breaches this covenant, the Grantor may reenter the Property and revest title in the City of Chicago. This covenant shall terminate upon the issuance of a Certificate of Completion by the Grantor.

FIFTH: The Grantee shall pay all real estate taxes and assessments on the Property when due. This covenant shall remain in effect without any limitation as to time.
