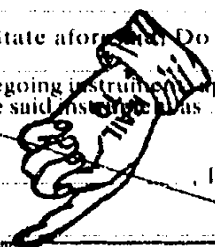

EXCULPATION EXECUTION CLAUSE AND ACKNOWLEDGEMENT TO ASSIGNMENT OF RENTS TO INDEPENDENCE BANK OF CHICAGO Dated July 15, 1993
