The Director of the Office of Thrift Supervision issued Order number(s) 91-116 dated February 28, 1991, placing First Savings Bank of Zion in receivership and appointing the Resolution Trust Corporation as Receiver of First Savings Bank of Zion pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

The Director of the Office of Thrift Supervision, by Order number(s) 91-116 dated February 28, 1991, incorporated a new federal savings association, First Federal Savings Bank of Zion, and issued its charter appointing the Resolution Trust Corporation as Conservator for First Federal Savings Bank of Zion, to have "all the powers of a conservator or receiver, as appropriate, granted under the Federal Deposit Insurance Act."

Certain assets of First Savings Bank of Zion, including the asset which is the subject of this document, have been transferred from First Savings Bank of Zion to First Federal Savings Bank of Zion; and, for the purposes of confirming said transfer, First Savings Bank of Zion does hereby grant, sell, assign, transfer, set over and convey to First Federal Savings Bank of Zion, its successors and assigns, without recourse or warranty, any interest First Savings Bank of Zion may have in the security document which is the subject of this document, together with the note, debt and claim secured by such security document and the covenants contained in such security document.

The Director of the Office of Thrift Supervision issued Order number(s) 91-660 dated November 1, 1991, placing First Federal Savings Bank of Zion in receivership and replacing the Conservator of First Federal Savings Bank of Zion with the Resolution Trust Corporation as Receiver of First Federal Savings Bank of Zion pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.



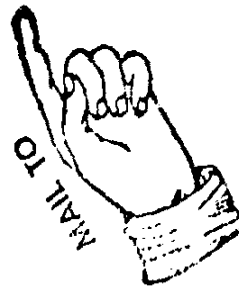
