INVESTIGATION REPORT ON THE PROPOSED CONSTRUCTION OF A NEW WATER MAIN AND SEWER MAIN UNDER THE INTERSTATE 55 CORRIDOR, FROM I-55 TO I-90, CHICAGO, ILLINOIS

The proposed construction of a new water main and sewer main under the Interstate 55 Corridor, from I-55 to I-90, Chicago, Illinois, is being investigated by the Department of Public Works, Division of Public Utilities. The project is located in the area bounded by I-55 to the north, I-90 to the south, and I-55 to the east. The project consists of the construction of a new water main and sewer main, and the installation of manholes and valves. The project is being investigated to determine the feasibility of the project, and to determine the location and depth of the main and manholes. The investigation is being conducted in accordance with the provisions of the Illinois Public Works Act, Chapter 240, Section 1-1.
