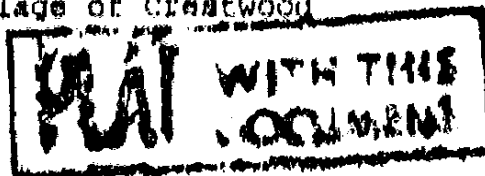

VILLAGE OF CRESTWOOD

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN
REAL ESTATE TO THE VILLAGE OF CRESTWOOD,
COOK COUNTY, ILLINOIS
COMMONLY KNOWN AS: 14230 SOUTH LAMON AVENUE
PROPERTY OWNER: DAMIAN J. CHURLIN AND CAROL CHURLIN

WHEREAS, there has been previously filed with the Village Clerk a Petition requesting annexation of the real estate described below to the Village of Crestwood, Cook County, Illinois; and
