- 33. Upon presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has or a felly paid, either before or after maturity, the Trustee shall have full authority to release this issued deed, the lien thereof, by proper instrument.
- 14. In case of the resignation, inability or refused to set of Trustee, the Beneficiary shall have the authorit in appoint a Successor in Trust. Any Successor in Trust hereunder shall have the identical fills, powers and authority as are herein given Trustee.
- 15. This Trust Deed and all provisions hereof, shall extend to and be blinding upon Grantors and all persons claim on her or through Grantors, and the word "Grantors" when used herein shall include all such persons and all persons liable for the payment of the indebtodness or any part thereof, whether or not a thin persons and have executed the Loan Agreement or this Trust Deed.
