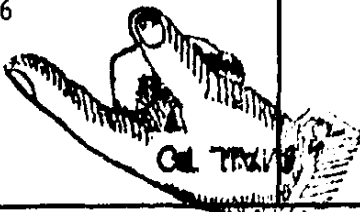

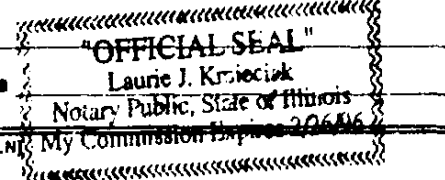

Exhibit A
