That at the special instance and request of said owner, the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of One Thousand Five Hundred Ninety and No/100 Dollars (\$1,590.00) and completed same on May 1, 1993.

That said owner is entitled to credits on account thereof as follows, to wit: Thirty-three Thousand Five Hundred and No/100 Dollars (\$33,500.00) leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Eight Thousand Four Hundred Ninety and No/100 Dollars (\$8,490.00), for which, with interest, the claimant claims a lien on said land and improvements.



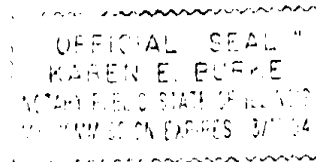
