the Note or the Loan Documents, and also in consideration of the sum of TEN DOLLARS (\$10.00), the receipt and sufficiency of which is hereby acknowledged, the Assignor and the Assignee hereby agree as follows:

- The Assignor does hereby sell, Assignment Clause. assign, transfer and set over unto the Assignee all right, title and interest of the Assignor in and to (a) all of the rents, issues, revenues, profits, avails and other sums (including income and receipts from the use and occupancy of any hotel rooms), of every kind and nature (including, but not limited to, payments or contributions for taxes, operating expenses and the like), payable by tenarch or guarantors under Leases (as hereinafter defined) of the Property; (b) all leases and occupancy agreements, whether now existing or hereinafter entered into for all or any part of the Property, including, but not limited to, the leases and occupancy agreements identified on Exhibit "B" attached hereto and by reference incorporated herein (collectively, the "Leases"), and any and all extensions and renewals thereof, and including any security deposits or interests therein now or hereafter held by the Assignor and the benefit of any guaranty of any of the obligations of any or all of the tenants executed in connection with any of the Leases; (c) rights and claims for damages against tenants arising out of defaults under any of the Leages, including rights to compensation with respect to rejected Leases pursuant to Section 365(a) or any replacement Section thereto of the Bankruptcy Code of the United States; and (d) the proceeds payable upon exercise of any option, including, but not limited to, an option to terminate or an option to purchase contained in any Lease.
- 2. Assignment Absolute and Immediate. This Assignment is absolute and is effective immediately. However, until notice is sent by the Assignee to the Assignor in writing that an event of default has occurred under the Note or under any other Loan Document (each such notice is hereinafter referred to as the "Notice"), the Assignor may receive, collect and enjoy the rents, income and profits accruing from the Property.
- The Assignor represents and warrants Representations. that: (a) there is no Lease in effect with respect to the Property which is not listed on Exhibit "B" attached hereto; (b) it has made no prior assignment or pledge of the rents assigned hereby or of the Assignor's interest in any of the Leases; (c) no default exists in any of the Leases and there exists no state of fact which, with the giving of notice or lapse of time or both, would constitute a default under any of the Leases; (d) the Assignor shall fulfill and perform each and every covenant and condition of each of the Leases by the landlord thereunder to be fulfilled or performed and, at the sole cost and expense of the Assignor, enforce (including through the termination of any of the Leases) the performance and observance of each and every covenant and condition of all such Leases by the tenants thereunder to be performed and observed; (e) none of the Leases have been modified or extended except as may be

noted in <u>Exhibit "B"</u>; (f) the Assignor is the sole owner of the landlord's interest in the Leases; (g) the Leases are valid and enforceable in accordance with their terms; and (h) no prepayment of any installment of rent for more than one (1) month due under any of the Leases has been received by the Assignor.

- Negative Covenants of Assignor. The Assignor shall not, without the Assignee's prior written consent, (a) execute an assignment or pledge of the rents from the Property or any part thereof, or of the Assignor's interest in any of the Leases, except to the Assignee; (b) cancel or terminate any of the Leases for any reason whatsoever, irrespective of how such right of cancellation termation is obtained, or permit the cancellation or termination of any Lease, or accept a surrender of any of the Leases; (n) modify, extend or otherwise alter the terms of any of the Leases; (d) accept prepayments of any installments of rents to become due under any of the Leases for more than one (1) month; (e) execute any lease of all or a substantial portion of the Property, except for actual occupancy by the lessee thereunder and which lease shall be subject to the approval of the Assignee as to form, content and tenant; (1) consent to any current or future tenant entering into a sublease tor all or any of the Property; (g) in any manner impair the value of the Property; or (h) permit the Leases to become subordinate to any lien other than a lien created by the Loan Documents or a lien for general real estate taxes not delinquent.
- Affirmative Covenants of Assignor. - This Assignment shall not operate to place responsibility for the control, management, care and/or repair of the Property upon the Assignee and the Usignee shall not be obligated to perform or discharge, nor does it hereby undertake to perform or discharge, any obligation, duty or liability under the Leases, or under or by reason of this Assignment, and the Assignor shall and does hereby agree to indemnify and to hold the Assignee harmless of and from any and all liability, loss or damage which it may or might incur under the Leases or under or by reason of this Assignment and of and from any and all claims and demands whatsoever which may be asserted against it by reason of any alleged obligations or undertaking on its part to perform or discharge any of the terms, covenants or agreements contained in the Leases, except any such claims or demands resulting from the acts or actions of the Assignee. Should the Assignee incur any such liability, loss or damage under the Leases or under or by reason of this Assignment, or in the defense of any sich claims or demands, the amount thereof, including costs, expenses and reasonable attorneys' fees, shall be secured hereby, and the Assignor shall reimburse the Assignee therefor immediately upon demand, with interest at the rate provided in the Note.
- c. Nothing herein contained shall be construed as constituting the Assignee a "Mortgagee in possession" in the absence of the taking of actual possession of the Property by the Assignee, pursuant to the provisions hereinafter contained. In the exercise of the powers herein granted the Assignee, no liability shall be asserted or enforced against the Assignee, all such liability being expressly waived and released by the Assignor.
- d. A demand on any lessee by the Assignee for the payment of the rent on any default claimed by the Assignee shall be sufficient

warrant to the lessee to make future payment of rents to the Assignee without the necessity for further consent by the Assignor.

- e. The Assignor does further specifically authorize and instruct each and every present and future lessee of the whole or any part of the Property to pay all unpaid rental agreed upon in any tenancy to the Assignee upon receipt of demand from the Assignee to pay the same, and the Assignor hereby waives the right, claim or demand it may now or hereafter have against any such lessee by reason of such payment of rental to the Assignee or compliance with other requirements of the Assignee pursuant to this Assignment.
- f. The Assignor hereby irrevocably appoints the Assignee as its true and lawful attorney with full power of substitution and with full power for the Assignee in its own name and capacity or in the name and capacity of the Assignor, from and after the service of the Notice of any default not having been cured, to demand, collect, receive and give complete acquittances for any and all rents, income and profits accruing from the Property, and at the Assignee's discretion to file any claim or take any other action or proceeding and make any settlement of any claims, in its own name or otherwise, which the Assignee may deem necessary or desirable in order to collect and enforce the payment of the rents, income and profits. Occupants of the Property are hereby expressly authorized and directed to pay any and all amounts due the Assignor pursuant to the Leases directly to the Assignee or such nominee as the Assignee may designate in writing delivered to and received by such occupants who are expressly relieved of any and all duty, liability or obligation to the Assignor in respect of all payments so made.
- g. In the event any lessee under any of the Leases should be the subject of any proceeding under the Federal Bankruptcy Code, as amended from time to time, or any other federal, state, or local statute which provides for the possible termination or rejection of the Leases assigned hereby, the Assignor covenants and agrees that if any of the Leases is so terminated or rejected, no settlement for damages shall be made without the prior written consent of the Assignee, and any check in payment of damages for termination or rejection of any such Lease shall be made payable bock to the Assignor and the Assignee. The Assignor hereby assigns any such payment to the Assignee and further covenants and agrees that upon the request of the Assignee, it shall duly endorse to the order of the Assignee any such check, the proceeds of which shall be applied to whatever portion of the indebtedness secured by this Assignment as the Assignee may elect.
- 7. <u>Default</u>. Upon, or at any time after, default in the payment of any indebtedness secured hereby or in the performance of any obligation, covenant, or agreement herein or in any of the Loan Documents or in the event of any default under any of the Loan Documents, the Assignee may, at its option, from and after receiving any required notice and expiration of applicable period

of grace, if any, and without regard to the adequacy of the security for the indebtedness hereby secured, either in person, or by agent with or without bringing any action or proceeding, or by receiver to be appointed by a court, enter upon, take possession of, manage and operate the Property or any part thereof; and do any acts which the Assignee deems proper to protect the security hereof; and, either with or without taking possession of the Property, in the name of the Assignor or in its own name sue for or otherwise collect and receive such rents, issues, profits, and advances, including those past due and unpaid, and apply the same, less costs and expenses of operation and collection, including, but not being limited to, reasonable attorneys' fees, management fees and broker's commissions, upon any indebtedness secured hereby, and in such order as the Assignee may determine. The Assignee reserves, within its own discretion, the right to determine the method of sollection and the extent to which enforcement of collection of delinquent rents shall be prosecuted, and shall not be accountable for more monies than it actually receives from the Property. The entering upon and taking possession of the Property or the collection of such rents, issues, profits and advances and the application thereof, as aforesaid, shall not cure or waive any default under Note or the other Loan Documents. The Assignor agrees that it shall facilitate in all reasonable ways the Assignee's collection of said rants, and shall, upon request by the Assignee, promptly execute a written notice to each lessee directing the lessee to pay rent to the Assignee.

Any default on the part of the Assignor hereunder shall constitute a default under the other Loan Documents.

- 8. Assignee's Right to Exercise Remedies. No remedy conferred upon or reserved to the Assignee herein or in the other Loan Documents or in any other agreement is intended to be exclusive of any other remedy or remedies, and each and every such remedy, and all representations herein and in the other Loan Documents contained shall be cumulative and concurrent, and shall be in addition to every other remedy given hereunder and thereunder or now or hereafter existing, at law or in equity or by statute. The gender and number used in this Assignment are used as a reference term only and shall apply the same effect whether the parties are of the masculine or feminine gender, corporate or other form, and the singular shall likewise include the plural.
- This Assignment may be executed in any number of and by different parties hereto in separate counterparts counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute but one and the same instrument.
- The Assignor represents and warrants to the Assignee that the execution and delivery of this Assignment of Rents is duly authorized by the partnership agreement of the Assignor in accordance with all laws and by resolutions heretofore adopted by the Board of Directors and/or Shareholders of the general partner of Assignor, in accordance with law and its bylaws, that said partnership agreement and resolutions have not been amended nor rescinded, are in full force and effect and that the officer or officers executing and delivering this Assignment of Rents for and on behalf of the general partner of the Assignor, is/are duly authorized so to act.
