TO HAVE AND TO HOLD the said real estate with the appurtenances, upon the terms, and for the uses and purposes herein and in said Trust Agreement set forth.

Full power and authority is hereby granted to said Trustee to improve, manage, protect and subdivide said real estate or any part thereof, to dedicate parks, streets, highways or alleys to locate any subdivision or part thereof, and to resubdivide said real estate as often as he deems it necessary to contract to sell to get options to purchase, to sell in any terms, to convey either with or without restrictions, covenants or any part thereof, or any part thereof, or to give in trust to him to grant, lease, let, hire, or otherwise encumber said real estate, or any part thereof, all or any of the little known powers and authorities given to said Trustee, to donate, to dedicate, to reserve, to lease or otherwise encumber said real estate, or any part thereof, to lease said real estate, or any part thereof, from time to time, in possession or reversion, by leases to commence in present or in future, and upon any terms to run for any period or periods of time, not exceeding in the case of any single lease the term of 195 years, and to renew or extend leases upon such terms and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof at any time or times hereafter by contract to make leases and to grant options to lease and option in renew, to let, to hire, to sell, to purchase the whole or any part of the real estate and to receive compensation therefor, and to grant easements, rights of way, or other rights or interests in and to said real estate or any part thereof, and to other persons to whom he may sell, or otherwise transfer, or assign any right, title or interest in, or about or concerning, appurtenant to said real estate or any part thereof, and to charge or collect any rent, or other consideration for the use or occupancy of any part of said real estate, or any part thereof, and to release, convey or assign any right, title or interest in, or about or concerning, appurtenant to said real estate or any part thereof, and to deal with said real estate and every part thereof in all other ways, and for such other considerations as it would be lawful for any person making the same, to deal with the same, whether similar to or different from the ways above specified at any time or times hereafter.

This renunciation is made upon the express understanding and conditions that neither American National Bank and Trust Company of Chicago, individually or as Trustee, nor its successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything it or they or its or their agents or attorneys may do or omit to do by or about the said real estate or funds, provided, however, that the Trustee, in its discretion, may consent thereto, in writing, to any action or proceeding which may be brought against the Trustee or any of the then beneficiaries, or all such liability being hereby expressly waived and released. Any personal obligation or indebtedness incurred by their attorney in fact, hereby irrevocably appointed in connection with said real estate may be entered into by it in the name of the then beneficiaries under said Trust Agreement as their attorney in fact, hereby irrevocably appointed for such purposes, or at the direction of the Trustee, in its own discretion, as Trustee of an express trust and not individually (and the Trustee shall have no obligations whatever in respect of any personal or indebtedness except only so far as the trust property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge thereof).

The interest of each and every beneficiary hereunder and testator shall Trust Agreement and of all persons claiming under them or any of them shall be only in the earnings, assets and proceeds resulting from the sale of any other disposition of said real estate, and such interest is hereby declared to be personal property, and therefore shall be liable to taxation as any other asset having any title or interest, legal or equitable. In or to said real estate as such, but only an interest in earnings, assets and proceeds thereof, as aforesaid, the intention hereof being to retain in said American National Bank and Trust Company of Chicago the entire real and equitable title in fee simple, in and to all of the real estate above described.

If the title to any of the above real estate is now or hereafter registered, the Registrar of Titles is hereby directed not to register or not in the certificate of title or duplicate thereof, or memorial, the words "in trust," or upon condition, or "with limitations," or words of similar import, in accordance with the statute in such case made and provided.

And the said grantor, S, hereby expressly waives . . . and releases . . . any and all right or benefit under and by virtue of any and all statutes of the State of Illinois, providing for exemption or homesteads from sale on execution or otherwise.
