NOTES

- 2. The registered effice must include a street or road address, a post office be a number; lone is not acceptable.
- 3. A corporation cannot get as its own registered agent.
- 4. If the registered office is changed from one county to another, then the corporation must file with the recorder of deads of the new county a contribute copy of the articles of incorporation and a certified copy of the statement of change of registered office. Such certified copies may be obtained ONLY from the Secretary of State.
- 5. Any change of registered agent must be by resolution adopted by the board of directors. This statement must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary)
- 6 The registered agent may report a change of the registered office of the corporation for which he or she is Shan College C registered agent. When the agent reports such a change, this statement must be signed by the registered agent.
