LIMITED POWER OF ATTORNEY

GOVERNMENT NATIONAL MORTGAGE ASSOCIATION, a corporation organized and existing under the laws of the United States of America within the Department of Housing and Urban Development, having its principal place of business in Washington, D.C. ("GNMA"), hereby constitutes and appoints GE Capital Asset Management Corporation, a corporation organized and existing under the laws of the State of Delaware ("GE-CAM") as its true and lawful attorney-in-fact, in its name, place and stead, and for its benefit, in connection with those GNMA mortgage loan pools related thereto where purchased by GE-CAM pursuant to that certain Contract of Sale entered into by and between GNMA and GE-CAM dated December 29, 1992 (the "Contract"), for the purpose of performing on behalf of or in the name of GNMA the following acts:

1. Completing the endorsements of promissory notes or other instruments evidencing indebtedness in such loan pools (collectively, the "Promissory Notes") from the defaulted issuers (as such term is used in the Contract) to GNMA and endorsing the Promissory Notes on behalf of GNMA from GNMA to GE-CAM without recourse;

2. Recording assignments of the mortgages, deeds of trust and other security instruments securing the Promissory Notes (collectively, the "Security Instruments") from the defaulted issuers (as such term is used in the Contract) to GNMA and preparing, executing and recording assignments of the Security Instruments from GNMA to GE-CAM; and

3. Any and all acts of any kind or nature whatsoever as GE-CAM deems necessary or desirable to effect such completion, endorsement, preparation, execution and recordation.

GNMA hereby ratifies and confirms all that GE-CAM, as such attorney and agent, shall legally do or lawfully cause to be done by virtue hereof.

GNMA further grants to GE-CAM full power and authority to do and perform all acts necessary to the sole discretion of GE-CAM to carry into effect the powers granted by or under this limited power of attorney as fully as GNMA might or could do with the same validity as if all and every such act had been herein particularly stated, expressed, and especially provided for, and hereby ratifies and confirms all that GE-CAM shall lawfully do or cause to be done by virtue of the powers and authority granted and contemplated hereby.

This limited power of attorney shall be effective as of March 1, 1993 and shall continue in full force and effect until December 31, 1993 unless extended or revoked in writing by GNMA.
