1.1 Definitions

As used herein, the following terms shall have the following meanings:

- (a) <u>Assignment</u>: The assignment, contained in Article 3 of this Mortgage, from Mortgager to Mortgagee, of all of Mortgagor's rights, title and interest in and to the Leases and the Rents.
- (b) Awards: All awards and payments made or hereafter to be made by any municipal, township, concty, state, Federal or other governmental agencies, authorities or boards or any other entity having the power of eminent domain to Mortgagor, including any awards and payments for any taking or all or a portion of the Mortgaged Property, as a result of, or by agreement in anticipation of, the exercise of the right of condemnation or eminent domain, or for any change or changes of grade of streets affecting the Mortgaged Property.
- (c) Beneficiary: Holder of the beneficial interest under the Trust ("beneficial interest").

- (d) <u>Buildings</u>: All building, improvements, alterations or appurtenances now, or at any time hereafter, located upon the Land or any part thereof.
- (e) <u>Default Interest Rate</u>: The lesser of (i) the interest rate of the Applicable Interest Rate, as defined in the Mortgage Note secured by this Mortgage, plus 4.25% per annum, or (ii) the highest contract rate allowed by law.
- (f) Event (s) of Default: The happenings and occurrences described in Article 5 of this Mortgage and as set forth in the Note.
- (g) Fixtures: All fixtures located upon or within the Land or Buildings or now or hereafter attached to, or installed in, or used in connection with, any of the Land or Buildings whether or not permanently affixed to the Mortgaged Property.
- (h) <u>Guaranty</u>: The guaranty, or collectively the guaranties, of even date executed by Guarantor guaranteeing the obligations of Mortgagor under this Mortgage, the Note and the Loan Documents.
- (i) Hazardous Marfrals: Any flammable explosives, radioactive materials, oil or petroleum or chemical liquids or solids, liquid or gaseous products or hazardous wastes, toxic substances and similar substances and materials, including all substances and materials defined as hazardous or toxic wastes, substances or materials under any applicable rule, regulation, ordinance or law.

- (j) Impositions: All (i) real estate and personal property taxes and other taxes and assessments, water and sewer rates and charges, and all other governmental charges and any interest or costs or penalties with respect thereto, and charges for any easement or agreement maintained for the benefit of the Mortgaged Property which at any time prior to or after the execution of the Security Documents may be assessed, levied, or imposed upon the Mortgaged Property of the rent or income received therefrom or any use or occupancy thereof, and (ii) other taxes, assessments, fees and governmental charges levied, imposed or assessed upon or against Mortgagor or any of its properties.
- (k) <u>Indebtedness</u>: The principal of and interest on and all other amounts, payments and premiums due under the Note and all other indebtedness of Mortgagor to Mortgagee under and/or secured by the Security Documents, or any amendments, modifications, renewals and extension of any of the foregoing.
- (1) Land: The real estate described in Exhibit A attached hereto and commonly known as 4546-48 North Sheridan, Chicago, Illinois.

- (m) Leages: Any and all leases, subleases, licenses, concessions or concessions or grants of other possessory interests now or hereafter in force, oral or written, covering or affecting the Mortgaged Property, or any part thereof, together with all rights, powers, privileges, options and other benefits of Mortgagor thereunder.
- (n) Mortgaged Property: The Land, the Buildings, the Fixtures, the Leases and the Rents together with:
- (i) all rights, privileges, permits, licenses, tenements, hereditament, rights-of-way, easements, appendages and appurterances of the Buildings belonging or in any way appertaining thereto and all right, title and interest of Mortgagor in and to any streets ways, alleys, strips or gores of land adjoining the Land or any ourt thereof;
- (ii) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Land, the Building, the Fixtures, the Leases and the Rents; and
- (iii) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Awards, or payments with respect to casualties.
- (0) Mortgages: First Cock Community Bank, F.S.B. and its successors and assigns and the holders, from time to time, of the Note.

- (s) Note: The Mortgage Note dated of even date with this Mortgage made by Mortgagor and the Beneficiary to the order of Mortgagee, in the principal amount of TWO HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED AND NO/100 Dollars (\$278,400.00) secured in part, by this Mortgage, together with any and all extensions, renewals, modifications and amendments thereof.
- (t) Obligations: Any and all of the covenants, promises and other obligations (other than the Indebtedness) made or owing by Mortgagor and others to or due to Mortgagee under and/or as set forth in the Note and/or the Loan Documents, and any and all extensions, renewals, modifications and amendments of any of the foregoing.

- (u) <u>Permitted Encumbrances</u>: The encumbrances described, with particularity, in Exhibit C attached hereto.
- (v) <u>Personalty</u>: All furniture, furnishings, equipment, machinery, trade fixtures and all other personal property (other than the Fixtures) owned by Mortgagor now or hereafter located in, upon or about the Land, the Building, together with all accessions, replacements and substitutions thereto or therefor and the proceeds and products thereof.
- (w) <u>Rents</u>: All of the rents, revenues, income, profits, deposits, tenders and other benefits payable under the Leases and/or orising from the use and enjoyment of all or any portion of the Mortgaged Property.
- (x) <u>Security Agreement</u>: The Security Agreement, contained in this Mortgago. wherein and whereby Mortgagor grants a security interest in the Fixtures to Mortgagee.
- (y) <u>Security Occuments</u>: This Mortgage, the Assignment, the Security Agreement and any all other documents now or hereafter securing the payment of the Indebtedness or the observance or performance of the Oblightions.

Article 2

GRAN'

- 2.1 Grant. To secure the payment of the Indebtedness and the performance and discharge of the Obligations, Mortgagor by these presents hereby grants, bargains, sells, assigns, mortgages, conveys and warrants unto Mortgages the Mortgaged Property, subject, however, to the Permitted Encumbrances, to have and to hold the Mortgaged Property unto Mortgages, its successors and assigns forever.
- 2.2 Condition of Grant. Provided always, that if Mortgagor promptly shall pay the entire Indebtedness as and when the same shall become due and payable and shall observe, perform and discharge the Obligations, then the Security Documents and the estate and rights hereby granted shall cease, terminate and become void, and shall be released by Mortgagee, at the cost and expense of Mortgagor, and, in cease of failure of the Mortgagee to so release this Mortgage, all claims for statutory penalties are hereby waived.
- 2.3 <u>Poctrine of Merger</u>. Upon the foreclosure of this Mortgage, no assigned Lease shall be destroyed or terminated by application of the doctrine of merger or as a matter of law unless Mortgages or any purchaser at such foreclosure sale so elects. No act by or on behalf of Mortgages or any such purchaser shall

constitute a termination of any assigned Lease unless Mortgages or such purchaser gives written notice thereof to the applicable tenant or subtenant.

Article 3

SECURITY INTEREST AND ASSIGNMENT OF LEASES AND RENTS

- 3.1 Security Agreement. This Mortgage shall be construed as a mortgage of a fee simple interest in real property and it shall also constitute a "Security Agreement" within the meaning of, and shall create a security interest under, the Uniform Commercial Code as adopted in the state in which the Mortgaged Property is located (the "UCC"), in the Fixtures.
- 3.2 Security Interest. Mortgagor hereby grants to Mortgagee a security interest under the UCC in the Fixtures and Mortgagee shall have all rights with respect thereto afforded to it by the UCC, in addition to, but not in limitation of, the other rights afforded to Mortgagee by the Security Documents.
- 3.3 Financing Statement. Mortgagor agrees to and shall execute and deliver to the Mortgagee, in form satisfactory to Mortgagee, such "Financing Statements", if any, and such further assurances as Mortgagee may, from time to time, consider reasonably necessary to create, perfect and preserve Mortgagee's liens upon the Fixtures, and Mortgagee, at the expense of Mortgagor, may or shall cause such statements and assurances to be recorded and re-recorded, filed and re-filed, at such times and places as may be required or permitted by law to so create, perfect and preserve such liens.

COVENANTS

4. Covenants

Until the entire Indebtedness shall have been paid in full, Mortgagor hereby covenants and agrees as follows (for purposes of this Article 4, all covenants and agreements of Mortgagor will be deemed to be covenants and agreements of the Guarantors):

4.1 <u>Compliance with Laws</u>. Mortgagor will promptly and faithfully comply with, conform to and obey all present and future laws, ordinances, rules, regulations and requirements of every duly constituted governmental authority or agency and of every Board of

Fire Underwriters having jurisdiction, or similar body exercising similar functions, which may be applicable to it or to the Mortgaged Property, or any part thereof, or to the use or manner of use, of occupancy, possession, operation, maintenance, alteration, repair or reconstruction of the Mortgaged Property, or any part whether or not such law, ordinance, rule, order, regulation requirement shall necessitate structural changes or improvements or interfere with the use or enjoyment of the Mortgaged Property.

- 4.2 Payment of Imposition. Mortgagor will duly pay and discharge, or cause to be paid and discharged, the Impositions, such Impositions or installments thereof to be paid prior to the day before any fine, penalty, interest or cost may be added thereto or imposed by law for the non-payment thereof; provided, however, that if, by andy Imposition may be paid in installments, Mortgagor may per the same in such installments.
- Mortgagor will keep the Mortgaged Property in 4.3 Repair good order and condition and make all necessary or appropriate repairs, replacements and renewals thereof and will use its best efforts to prevent any act or thing which might impair the value or usefulness of the Mortgaged Property, and Mortgagor will obtain the written consent of Mortgage prior to (i) making any alterations or additions to the Mortgage Property or (ii) removing any of the Buildings or Fixtures.
- Mortgagor #111 maintain insurance upon the Insurance. Mortgaged Property against loss by Cre and such other hazards, casualties and contingencies as are normally and usually covered by extended coverage policies in effect in the locality where the Mortgaged Property is situated and such other risks as may be specified by Mortgagee, from time to time, in amounts and with insurers acceptable to Mortgagee but not less than the lesser of (a) the amount of the Indebtedness, or (b) 110% of the replacement value of the Buildings, Fixtures and Personalty. Mortgagor shall cause each insurance policy issued in connection therewith to (and the insurer issuing such policy to dertify to provide Mortgagee) that (i) loss payments will be payable to Mortgagee as its interests may appear, such payments to be applied to the restoration, repair or replacement of the Mortgaged Property; provided, however, that if an Event of Default has occurred and is continuing or an event has occurred and is continuing which with the passage of time or the giving of notice would constitute an Event of Default, then such payments shall be applied to the payment of the Indebtedness; (ii) the interest of Mortgagee shall be insured regardless of any breach or violation by Mortgagor of any warranties, declarations or conditions in such policy; (iii) if any such insurance policy be subject to cancellation or be endorsed or sought to be endorsed to effect a change in coverage for any reason whatsoever, such insurer will promptly notify Mortgagee and such cancellation or change shall not be effective be effective as

to Mortgages until thirty (30) days after receipt by Mortgages of such notice; and (iv) Mortgages may, but shall not be obligated to, make premium payments to prevent such cancellation, and that such payments shall be accepted by the insurer. For purposes of this replacement value of the Buildings, Fixtures Section, Personalty shall be equal to the cost of replacing the Buildings, Fixtures and Personalty, exclusive of the cost of excavation, foundations and footings below the lowest basement floor and shall be determined from time to time during the terms of the Note (but no more recently than one in any 24 calendar months) at the written request of Mortgagee by an engineer, appraiser, architect or contractor designated by Mortgagee, approved in writing by Mortgagor, and paid by Mortgagor. In addition, Mortgagor shall Mortgagor, and paid by Mortgagor. In addition, Mortgagor shall furnish to Mortgagee duplicate executed copies of each such policy at the time of execution hereof, and copies of each renewal policy not less than thirty (30) days prior to the expiration of the original policy or the preceding renewal policy (as the case may be), together with receipts or other evidence that the premiums thereon have been paid; and furnish to Mortgagee on or before thirty (30) days after the close of each fiscal year of Mortgagor a statement of Mortgagor of the amounts of insurance maintained in compliance with the Subsection, of the risks covered by such insurance and of the insurance company or companies which carry such insurance.

- 4.5 Restoration Following Casualty. In the event of the happening of any casualty, of any kind or nature (whether insured against or not), resulting in damage to or destruction of the Mortgaged Property, Mortgagor will give prompt notice thereof to Mortgagee, and Mortgagor will promptly restore, repair, replace, rebuild or alter the Mortgaged Property as nearly as possible to its value and condition immediately prior to such damage or destruction.
- 4.6 Performance of Leases and Other Agreements. Mortgagor will duly and punctually perform all covenants and agreements expressed as binding upon it under the Lease and other agreements to which it is a party with respect to the Mortgaged Property or any part thereof, and will use its best efforts to enforce or secure the performance or each and every obligation and undertaking of the respective leasees under the Lease, and will appear and defend, at its cost and expense, any action or preceding arising under or in any manner connected with the Lease or the obligations and undertakings of the lessor thereunder. Mortgagor will immediately notify Mortgagee in writing of any notice of default received by Mortgagor from the Lessor thereunder.
- 4.7 <u>Inspection</u>. Mortgagor will permit Mortgagee, at all reasonable times, to inspect the Mortgaged Property. Mortgagee shall have the right to enter onto the Mortgaged Property, at all times, upon reasonable notice, to inspect the mortgaged Property for the existence of Hazardous Materials on the Mortgaged Property

and to determine the compliance of the Mortgaged Property and its use with any law, rule or regulation relating to industrial hygiene or environmental conditions, including soil and ground water conditions and the compliance of the Mortgagor and the Mortgaged Property with the conditions and covenants set forth herein with respect to Hazardous Materials.

- 4.8 Hold Harmless. Mortgager will employ legal counsel acceptable to the Mortgages and who is not also representing the Mortgagee in any other matter, and will defend and hold Mortgagee harmless from any action, proceeding or claim affecting the Mortgaged Property, or the validity of the Note or the Loan Documents. Mortgager shall appear in and defend (or pay the reasonable expenses of Mortgagee to defend, if mortgager elects to allow Mortgagee to handle such defense) any action or proceeding purporting to affect the security of this Mortgage and/or the rights and/or powers of mortgagee hereunder, and Mortgager shall pay all costs and expenses (including costs of evidence of title and attorneys' fees) in any action or proceeding in which Mortgagee may so appear and/or any suit brought by Mortgagee to foreclose this Mortgage, to enforce any obligations secured by this Mortgage, and/or to prevent the breach hereof. Mortgagor's obligations under this Section 4.8 shall survive payment of the Indebtedness.
- 4.9 Books and Records. Mortgagor will maintain full and complete books of account and other records reflecting the results of its operations (in conjunction with its other operations as well as its operations of the Mortgaged Property), in accordance with generally accepted accounting principles, and furnish or cause to be furnished to Mortgagee such financial data and other information, including, without limitation, copies of all Leases, as Mortgagee shall, from time to time, reasonably request with respect to Beneficiary and the ownership and operation of the Mortgaged Property, and Mortgagee shall have the right, at reasonable times and upon reasonable notice, to radit Beneficiary's books of account and records.
- 4.10 Awards. Mortgagor will file and prosecute its claim or claims for any Awards in good faith and with due diligence and cause the same to be collected and paid over the Mortgagee, and hereby irrevocably authorizes and empowers Mortgagee, if it so desires, to file such claim and collect any Awards and agrees that the proceeds of any Awards will be applied by Mortgagee in reduction of any portion of the Indebtedness as Mortgagee may determine in accordance with Article 7 hereof.
- 4.11 <u>Licenses</u>. Mortgagor shall keep in full force and effect all licenses, permits and other governmental approvals which are necessary for operation of the Mortgaged Property and related facilities, and furnish evidence satisfactory to Mortgagee that the Mortgaged Property and the use thereof comply with all applicable zoning and building laws, regulations, ordinances and other

applicable laws.

- 4.12 Junior Financing. Mortgager shall not, without the prior written consent of Mortgages, incur any additional indebtedness or create or permit to be created or to remain, any mortgage, pledge, lien, lease, encumbrance or change on, or conditional sale or other title retention agreement, with respect to the Mortgaged Property or any part thereof or income therefrom, other than the Security Documents and the Permitted Encumbrances.
- 4.13 Representations and Warranties of Mortgagor. Mortgagor hereby represents and warrants to Mortgages that:
- (a) Mortgagor and Beneficiary each are qualified to do business in every jurisdiction in which the nature of its business or properties make such qualification necessary, and is in compliance with all laws, regulations, ordinances and orders of public authorities applicable to Mortgagor or Beneficiary, as the case may be.
- (b) The Nove, the Mortgage and the Guaranty will not violate any provision of existing law (including, but not limited to, any law relating to usury), any order of any court or other agency or government, or any indenture, agreement or other instrument to which Mortgagor or each Guarantor is a party or by which Mortgagor or each Guarantor or any of their property is bound, or be in conflict with, result in a breach of or constitute (with due notice and/or lapse of time) a default under any such indenture, agreement or other instrument, or violate the Partnership Agreement of the Mortgagor or each Guarantor or result in the creation or imposition of any lim, charge or encumbrance of any nature whatsoever upon any of the property or assets of Mortgagor or each Guarantor, except as contemplated by the Note and the Sacurity Documents, and no action with respect thereto by Mortgagor or each Guarantor is required.
- (c) No consent or approval of any regulatory body to the execution, delivery and performance of the Note and the Security Documents, the Guaranty or the transactions contemplated thereby is required by law.
- (d) There are not suits, proceedings or investigations pending or to their knowledge, threatened against or against or affecting Mortgagor or any Guarantor, at law or in equity, or before or by any governmental or administrative agency or instrumentality which, if adversely determined, would have a material adverse effect on the business or condition of Mortgagor or any Guarantor.
- (e) No judgement, decree or order of any court or governmental or administrative agency or instrumentality has been issued against any Guarantor or Mortgagor which has or may have any

material adverse effect on the business or condition of any Guarantor or Mortgagor.

- (f) All information, reports, papers and data given to Mortgagee with respect to Mortgagor, each Guarantor or others obligated under the terms of the Security Documents are accurate and correct in all material respects and complete insofar as completeness may be necessary to give Mortgagee a true and accurate knowledge of the subject matter thereof.
- (g) Mortgagor has good and marketable title in fee simple to the Mortgaged Property and good and marketable title to the Fixtures, free and clear of any prior assignments, liens, charges, encumbrances, security interests and adverse claims whatsoever except the Parmitted Encumbrances.
- (h) Mortgager has not executed any prior collateral assignment of the Lease or of its right, title, interest therein, Mortgager has delivered to Mortgagee a true and complete copy of Lease assigned hereunder, together with all amendments, supplements and other modifications, and to the best of Mortgagor's knowledge, no material default by Nortgagor or Lessor under the Lease remains undered.
- (i) The Permitted Encumbrances have not materially interfered with the operation of the Mortgagod Property, nor does Mortgagor reasonably foresee any material interference arising from the Permitted Encumbrances during the terms of the Note.
- (j) Mortgagor and all Guarantors have filed all Federal, state, country and municipal income tax returns required to have been filed by them and have paid all taxes which have become due pursuant to any assessments received by them, and mortgagor and all Guarantors do not know of any basis for additional assessment in respect to such taxes.
- (k) The Mortgaged Property is being, and will continue to be, used for commercial purposes.
- (1) No release (a "Release") of Hazardous Material has occurred on the Land or other real property in the state in which Mortgaged Property is located now or previously owned by Mortgagor or any of the partners of Mortgagor (if Mortgagor is a partnership), or any of the stockholders or other persons having a legal or beneficial interest in Mortgagor (if Mortgagor is a corporation, trust or other legal entity), except those Hazardous Materials listed in the Environmental Report as defined by Paragraph 7.8 of the Loan Agreement. Mortgagor has not received any notice from any governmental agency or from any tenant under a Lease or from any other party with respect to any such Release.

Breach of such representations and warranties shall constitute an Event of Default under Section 5.5 hereof. Mortgagor shall promptly give written notice to Mortgagee of any breach under this Section 4.13.

- 4.14 Mechanics Lien. Mortgagor shall not permit or suffer andy mechanics' lien claims to be filed or otherwise asserted against the Premises and Mortgagor shall promptly, and in any event within thirty (30) days after filing, discharge or cause to be discharged the same in case of the filing of any claims for lien or proceeding for the enforcement thereof; provided, however, that in connection with any such lien or claim which Mortgagor, may in good faith desire to contest, Mortgagor may contest the same by appropriata legal proceedings diligently prosecuted, but only if Mortgagor stall cause Greater Illinois Title Company (the "Title Company"), to issue an endorsement to the Title Policy insuring over the exception created by such lien (including furnishing such security or indemity as the Title Company requires to issue such endorsement) or provide such other security and indemnification as may be reasonably acceptable to Lender.
- 4.15 <u>Hazardous Materials</u>. (a) Without limiting the generality of Section 4.1 hereof, Mertgagor shall not cause or permit the violation of any law relating to industrial hygiene or environmental conditions in connection with the Mortgaged Property, including soil and ground water conditions, or use, generate, manufacture, store or dispose of any Hazardous Materials on, under or about the Mortgaged Property. Without Mortgagee's prior written consent, which consent shall not be unreasonably withheld, Mortgagor shall take no remedial action, except for the "Asbestos Removal Project" as defined in Paragraph 7.8 of the Loan Agreement, with respect to any Hazardous Materials on, under or about the Mortgaged Property, and shall not enter into any settlement agreement, consent decree or other compromise or agreement relating to any such Hazardous Materials.
- (b) Mortgagor shall indemnify and hold Mortgage harmless from any loss, liability, cost, expense and/or claim /including without limitation the cost of any fines, remedial action, damage to the environment and cleanup and the fees of attorneys and other experts) arising from the use, Release or disposal any Hazardous Materials on, under or about the Mortgaged Property or the transport of any hazardous Materials to or from the Mortgaged Property; and the violation of any law relating to industrial hygiene or environmental conditions in connection with the Mortgaged Property, including soil and ground water conditions; and the breach of any of the representations, warranties and covenants of Mortgagor with respect to Hazardous Materials set forth in this Section 4.15 Section 4.13 hereof.

Article 5

EVENTS OF DEFAULT

5. Events of Default

The term "Event (s) of Default", as used in the Security Documents and in the Note, shall mean the occurrence or happening, from time to time, of any one or more of the following:

- 5.1 Payment of Indebtedness. If Mortgagor shall default in the due and punctual payment of all or any portion of any instalment of the Indebtedness as and when the same shall become due and payable, whether at the due date thereof or at a date fixed for prepayable or by acceleration or otherwise, and such default shall continue for a period of ten days after written notice thereof by Mortgages to Mortgagor.
- 5.2 Performance of Obligations. If Mortgagor shall default in the due observance or performance of any of the Obligations other than payment of money and such default shall not be curable, or if curable shall continue for a period of thirty (30) days after written notice thereof from Mortgagee to Mortgagor (unless such default, if curable, requires work to be performed, acts to be done or conditions to be remedied which by their nature cannot be performed, done or remedied, as the case may be, within such 30 day period and Mortgagor shall commence to cure such default within such 30 day period and shall thereafter diligently and continuously process the same to completion but in no event shall the period for cure exceed 120 days unless otherwise agreed by Mortgagee).
- 5.3 Bankruptcy. Receivership. Insolvency. Etc. If voluntary or involuntary proceedings under the Federal Bankruptcy Code, as amended, shall be commenced by or against Bertgagor or any Guaranter or bankruptcy, receivership, insolvency, reorganization, dissolution, liquidation or other similar proceedings shall be instituted by or against Mortgagor or any Guaranter's with respect to all or any part of Mortgagor's or any Guaranter's property under the Federal Bankruptcy Code, as amended, or other law of the United States or of any state or other competent jurisdiction, and if such proceedings are instituted against Mortgagor or any Guaranter, it shall consent thereto or shall fail to cause the same to be discharged within thirty (30) days.

- 5.6 <u>Destruction of Improvements</u>. If any of the Buildings is demolished or removed or demolition or removal thereof is imminent, eminent domain proceedings excepted.

6.9 No Conditions Precedent to Exercise of Remedies.
