FIFTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR SHIBUI SOUTH CONDOMINIUM

THIS FIFTH AMENDMENT ("Fifth Amendment") amends that certain Declaration of Condominium Ownership for Shibui South Condominium dated March 5, 1993 and recorded with the Cook County Recorder's Office as Document No. 93168945, as amended (said Declaration and any amendments thereto is herein referred to as the "Declaration"), and is executed as of this and day of (NO) 1993 by American National Bank and Trust Company of Chicago, not personally but solely as Trustee under Trust Agreement dated January 1, 1984 and known as Trust No. 61991 (hereinafter referred to as "Declarant").

WITNESSETH:

WHEREAS, he real estate described in Exhibit A of the Declaration situated in the City of Oak Forest, Cook County, Illinois (hereinafter referred to as the "Submitted Parcel") has heretofore been submitted to the provisions of the Condominium Property Act of the State of Illinois, as amended (the "Aci"), pursuant to the Declaration; and

WHEREAS, pursuant to the Act and pursuant to Article 12 of the Declaration, the Declarant reserved the right from time to time to annex and add to the Submitted Parcel and thereby add to the plan of condominion ownership created by the Declaration; and

WHEREAS, the Declarant, pursuant to Article 12 of the Declaration, desires to annex and add the real estate described on Exhibit A-1" attached hereto ("Additional Parcel"), to the Submitted Parcel and thereby add to the plan of condominium ownership created by the Declaration: and

WHEREAS, the Additional Parcel is a portion of the Future Development Parcel under the Declaration as described in Exhibit "C" therein; and

WHEREAS, the Declarant desires to amend the Declaration as it relates to the Plat of Survey (Exhibit "A" thereto) and to the percentage of ownership interest in the common elements for condominium units (Exhibit "B" thereto) based upon the annexation of the Additional Parcel; and

WHEREAS, under Article 12 of the Declaration a power coupled with an interest is granted to the Declarant acting by and through its duly authorized officers as artorney-in-fact to shift the percentage of ownership in the common elements appurtenant to each condominium unit to the percentages set forth in each Amendment to Declaration.
