JUDGE'S DEED

Whereas on August 22, 1990, In case number 90 D 04889, entitled MISBAU A. ORIOLA vs. IRMA LEE ORIOLA, Petitioner, MISBAU A. ORIOLA, was granted a Judgment of Dissolution of Marriage.
