THIS MORTGAGE ("Security Instrument") is made this 19th day of August 1987 by and between STEPHEN R. CULP and KAREN L. MCKEOWN, WIDOW, as Lender, and L. CULP, HUSBAND AND WIFE AND ("Borrower").
