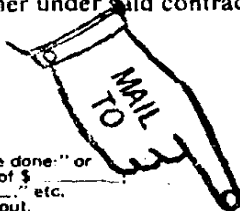
for and in said improvement, and that on May 15, 1993, the claimant completed thereunder all required by said contract to be done.

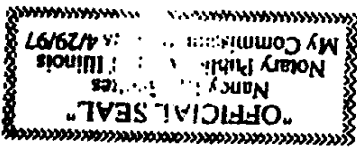
