- 12. Notice. 20. Release. Upon payment of all sums secured by this Mortgage, Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any.

21. Watver of Homestead. Borrower hereby waives all rights of homestead exemption in the Property.
