RESOLUTION NO. 93-R-75

Solomon Schechter Day Schools, an Illinois not-for-profit corporation (the "Applicant"), is the contract purchaser of the property commonly known as 3210 Dundee Road, Northbrook, Illinois (the "Subject Property").

In 1987, certain Restrictive Covenants and an Ingress/Egress Access Easement were recorded against the Subject Property for the benefit of, among others, the Village of Northbrook (the "Village"). The President and Board of Trustees of the Village, after due and careful consideration, believe that it would be in the Village's best interest to release the Restrictive Covenants and Access Easement in their entirety in order to allow the Applicant to use the Subject Property in accordance with the Development Agreement approved concurrent with this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Northbrook, County of Cook and State of Illinois, THAT:

Section 1. Release of Restrictive Covenant.

The Village Actorney is hereby authorized to take all fecessary action to cause those certain Restrictive Covenants, recorded against the Property in the office of the Cook County Recorder of Deeds as Document Nos. 88007496 and 88007497, to be terripated and released.

Section 2. Release of Access Easement.

The Village President is hereby authorized and directed to execute the telease of Easement attached hereto as Exhibit A, and by this reference incorporated herein and made a part hereof.

Section 7. Effective Date.

This Resolution shall be in effect upon, but not before, the receipt by the Village Clerk of evidence that the title to the Subject Property has been in afferred to the Applicant (in its own name or in a land trust of which it is the sole beneficiary).

In the event that evidence of such acquisition of title is not presented to the Village Clerk on or before July 30, 1993, the Village shall have the right, in its sole and absolute discretion, to be exercised at any time after July 30, 1993, to repeal this Resolution.
