TO HAVE AND TO HOLD such property and Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances after-acquired title or reversion in and to the beds of ways, streets, avenues and alleys adjoining the ripoerty, and rents (subject however to the rights and authorities given herein to Lender to collect and apply such rents), royalties, mineral. To secure to Lender on condition of the repayment of the Personal Home Equity Line of Credit indebtedness evidenced by a Personal Home Equity Line of Credit Agreement and Disclosure Statement ("Agreement") of even date herewith and by Borrower's Variable Interest Rate Promissory Note ("Note") of even date herewith, in the principal sum of \$\Sigma110,000.00\$, or so much thereof as may be advanced and outstanding, with interest thereon, providing for monthly installments of interest, with the principal balance of the indebtedness, if no sooner paid or required to be paid, due and payment of years from the date thereof; the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage; and the performance of the covenants and agreements of Borrower contained herein and in the Agreement and the Note. The Agreement, the Note and this Mortgage are collectively referred to as the "Credit Documents". The Credit Documents contemplate, and this Mortgage permits and secures, future advances.

The Note evidences a "Revolving Credit" as defined in the Illinoi. Revised Statutes Chapter 17. Paragraph 312.3. The lien of this

The lien of this Mortgage secures payment of any existing indebtedness and future advances made pursuant to the Note, to the same extent as if such future advances were made on the date of the execution of this Mortgage, without regard to whether or not there is any advance made at the time this Mortgage is executed and without regard to whether or not there is any und-or dness outstanding at the time any advance is made.

Notwithstanding anything to the contrary herein, the Property shall include all of Borrower's right, title and interest in and to the real property described above, whether such right, title, and interest is acquired before or after execution of this Mortgage. Specifically, and without limitation of the foregoing, if this Mortgage is given with respect to a leasehold exact held by Borrower, and Borrower subsequently acquires a fee interest in the real property, the lien of this Mortgage shall attach to and include the real property by Borrower.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to grant, convey and mortgage the Property and that the Property is unencumbered except for encumbrances of record. Borrower evenants and warrants (if Borrower is a Trust, then Borrower covenants) that Borrower will defend generally the fitle to the Property against all claims and demands, subject to encumbrances, covenants, conditions, restrictions and easements of record. Borrower covenants that Borrower will neither take nor permit any action to partition or subdivide the Property or otherwise change the legal description of the Property or any part thereof, or change in any way the condition of title of the Property or any part thereof.

Borrower acknowledges that the Note allows for changes in the interest rate, and that the Lender may, pr. or to the expiration of the term of the Note, cancel future advances thereunder for certain specified periods of time, and/or require repayment or the constanding balance under the Note in the event of a Default thereunder. Increases in the interest rate will result in higher payments. Decerse in the interest rate may result in lower payments.

COVENANTS, Borrower and Lender covenant and agree as follows:

1. PAYMENT OF PRINCIPAL AND INTEREST. Borrower shall promptly pay when due without setoff, or deduction. The principal of and interest on the debt evidenced by the Note, together with any late charges and other charges imposed under the Note.

2. APPLICATION OF PAYMENTS. All payments received by Lender under the Note and this Mortgage shall be applied by Lender first in payment of amounts payable to Lender by Borrower under paragraphs 6 and 28 of this Mortgage, then to interest due on the Note, then to charges payable under the Agreement, and then to the principal of the Note.

3. PRIOR MORTGAGES AND DEEDS OFTRUST; CHARGES; LIENS. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage including Borrower's covenants to make any payments when due. Borrower shall pay all taxes, assessments, charges, lines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or ground rents, if any. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. The Borrower shall make these payments directly, and promptly furnish to Lender receipts evidencing the payments.

Borrower shall promptly discharge any lien which has priority over this Mortgage other than the prior mortgage described above, unless Borrower; (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender; (b) contests, in good faith, the lien by or defends against enforcement of the lien in legal proceedings which in the Lender's opinion, operate to prevent the enforcement of the lien or forfeiture of any part of the Property; or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Mortgage. If Lender determines that any part of the Property is subject to a fien which may attain priority over this Mortgage, Lender may give Borrower a notice identifying the lien. Borrower shall satisfy the lien or take one or more of the actions set forth in this Mortgage, within 10 days of the giving of notice.

4. HAZARD INSURANCE. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage" and such other hazards as Lender may require; provided that Lender shall not require that the amount of such coverage exceed that amount of coverage required to pay the sums secured by this Mortgage and all other mortgages and deeds of trust with respect to the Property, but in no event shall such amounts be less than the amount necessary to satisfy the coinsurance requirements contained in the insurance policy. The insurance earrier providing the insurance shall be chosen by Borrower, subject to approval by Lender which shall not be unreasonably withheld. All premiums on insurance policies shall be paid by Borrower when due.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damages, if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage, whether or not then due, with any excess paid to Borrower. If Borrower abandons the Property or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender is interocably authorized to settle the claim and to collect and apply the insurance proceeds at the Lender's sole option either to restoration or repair of the Property or to the sums secured by this Mortgage, I ender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due. The 30 day pecied will begin when the notice is given.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to in the Mortgage or change the amount of such installments. If the Property is acquired by Lender, all right, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to the sale or acquisition shall pass to Lender to the extent of the sums secured by this Mortgage immediately prior to such sale or

5. PRESERVATION AND MAINTENANCE OF PROPERTY: LEASEHOLDS: CONDOMINIUMS: PLANNED UNIT DEVELOP-MENTS, Borrower shall use, improve and maintain the Property in compliance with applicable laws, statutes, ordinances, requirements and regulations, shall keep the Property in good condition and repair including the repair or restoration of any improvements on the Property which may be damaged or destroyed, and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any has if this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or planned unit development, the bylave and regulations of the condominium or planned unit development, and constituent documents.

6. PROTECTION OF LINDER'S RIGHTS IN THE PROPERTY If Borrower fails to perform the covenants and agreements comained in this Mortgage or in the additional Credit Documents, or there is a legal proceeding that may effect Lender's rights in the Property (such as a proceeding in bankruptcy, probage for condemnation, or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the value of the Property and Lender's rights in the Property. 7. INSPECTION. Lender or its agent may make reprenable entries upon and inspections of the Property. Lender shall give Borrower notice at the time of or prior to an inspection specifying ressonable cause for the inspection.

8. CONDEMNATION. The proceeds of any award or chain for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conviyance in lieu of condemnation, are hereby assigned and shall be paid to Lender, subject to the terms of any mortgage, deed of trust or other occurry agreement with a lieu which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority to effect at this paragraph. Lender is hereby authorized to apply or release such moneys received or make settlement for such moneys in the same manner and with the same effect as provided in this Mortgage for disposition or settlement of proceeds of Hazard Insurance. No settlement for condemnation damages shall be made without Lender's prior written approval.

9. BORROWER NOT RELEASED,; FORBEARANCE BY LENDER NOT A WAIVER. Extension of the time for payment, acceptance by Lender of payments other than according to the terms of the Note, acceptance in payment terms of the sum secured by this Mortgage granted by Lender to any successor in interest of Borrower shall not open to be received to commence proceedings against any successor in interest or any guarantor or surely thereof. Lender shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify payment terms of the sams secured by this Mortgage by reason of any demand made by the original Borrower or Borrower's successors in interest. Any forbearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or remedy. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event.

10. SUCCESSORS AND ASSIGNS BOUND; IOINT AND SEVERAL LIABILITY; CO-S'GNERS. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 18. Borrower's covenants and agreements shall be joint and several. Any Borrower who co-signs this Mortgage but does not execute the Note: (a) is co-signing this Mortgage only to mortgage, grant and convey that Borrower's interest in the Property under the terms of this Mortgage and to release homestead rights; if any; (b) is not personally obligated to pay the sums secured by this Mortgage; and (e) agrees that Lender and any other Borrower may agree to extend, modify, forebear or make any accommodations with regard to 0.2 terms of this Mortgage or the Note without that Borrower's consent and without releasing that Borrower or modifying this Mortgage as to data Borrower's interest in the Property.

IL LOAN CHARGES. If the loan secured by this Mortgage is subject to a law which sets maximum for n charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan except the permitted limits, then:
(a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note, or by making a direct payment to Borrower. If a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge.

12. LEGISLATION AFFECTING LENDER'S RIGHTS. If enactment or expiration of applicable laws has the effect of pendering any provision of the Note or this Mortgage unenforceable according to its terms. Lender, at its option, may require immediate payment in full of all sums secured by this Mortgage and may invoke any remedies permitted by paragraph 19.

13. NOTICES. Any notices to Borrower provided for in this Mortgage shall be given by hand delivering it or by mailing such notice by registered or certified mail unless applicable law requires use of another method. The Notice shall be direct to the Property Address or any other address Borrower designates by notice to Lender. Any notice to Lender shall be given by first class mail to Lender's address stated herein (Attn: Consumer Lending Department) or any other address Lender designates by notice to Borrower. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender on the date hand delivery is actually made, or the date notice is deposited into the mail.

14. GOVERNING LAW: SEVERABILITY. This Mortgage shall be governed by federal law and the law of Illinois. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provisions. To this end the provisions of this Mortgage and the Note are declared to be severable.

15. BORROWER'S COPY. Each Borrower shall be given one confirmed copy of the Note and of this Mortgage.

16. REMEDIES CUMULATIVE. Lender may exercise all of the rights and remedies provided in this Mortgage and in the Credit Documents, or which may be available to Lender by law and all such rights and remedies shall be cumulative and concurrent, and may be pursued singly, successively or together, at Lender's sole discretion, and may be exercised as often as occasion therefor shall occur.

17. EVENTS OF DEFAULT.

a. Notice. An Event of Default will occur hereunder upon the giving by Lender of a written notice to Borrower of Borrower's breach or violation of Borrower's covenants under any of the Credit Documents. Such notice shall be given to Borrower in accordance with paragraph 13 hereof, and shall specify the nature of Borrower's breach or violation.

The notice shall further inform Borrower of the right, if any, under applicable law, to reinstate his revolving line of credit under this Mortgage

after default.

i. The events are: (i) if Borrower engages in b. Events of Default, Set forth fraud or material utisrepresentation in connection with this Mortgage or the Agreement; (ii) if Borrower fails to meet the repayment terms of the Mortgage or the Agreement; (iii) if Borrower does not pay when due any sums secured by this Mortgage; or (iv) if Borrower's action or inaction adversely affects the Property, or Lender's rights in the Property.

18. TRANSFER OF THE PROPERTY. All of the indebtedness owed pursuant to the Agreement, the Note, and/or this Mortgage shall be

immediately due and payable if Borrower, or the beneficiary of the Trust, if any, sells, conveys, assigns or transfers, or promises or contracts to self, convey, assign or transfer, all or any part of the Property or any interest (including but not limited to the articles of agreement for deed) therein, including all or any part of the beneficial interest in the Trust (whether for absolute or collateral purposes), if any, or amends, or terminates any ground leases affecting the Property, or if title to the Property, or any direct or indirect interest therein, is otherwise sold or transferred, volumerily or involuntarily, including without limitation, sale or transfer in any proceeding for foreclosure or judicial sale of the Property or beneficial interest in the Trust, if any, in each case without Lender's prior written consent.

19. ACCELERATION; REMEDIES (INCLUDING FREEZING THE LINE). Upon the existence of an Event of Default, Lender may, at its sole option, terminate the Line, declare all of the sums secured by this Mortgage to be immediately due and payable without further demand,

and invoke any remedies permitted by applicable law.

Lender shall be entitled to collection of all reasonable costs and expenses incurred in pursuing the remedies provided in this paragraph 19,

including, but not limited to, reasonable attorneys' fees.

As additional specific protection, notwithstanding any other term of this Mortgage, Lender, without declaring or asserting an Event of Default or invoking any of its remedies pertaining to Events of Default, may, immediately and without notice, refuse to make additional extensions of credit under the Line, or reduce your Maximum Credit Limit under the Line upon the occurrence of any event enumerated in paragraph 17 of this Mortgage. Notice of any such refusal or reduction shall be given in accordance with the provisions of paragraph 13 of this Mortgage. Refusal of additional credit extensions, or reduction of credit under the Line will not preclude Lender from subsequently exercising any right or remedy set forth herein or in any of the Credit Documents

20. ASSIGNMENT OF RENTS; APPOINTMENT OF RECEIVER; LENDER IN POSSESSION, As additional security hereunder, Borrower hereby assigns to Lorder the rents of the Property, provided that prior to acceleration under paragraph 19 or the occurrence of an Event of Default hereunder or abandonment of the Property, Borrower shall have the right to collect and retain such rents as they become due and
