HOME EQUITY LINE MORTGAGE EXTENSION AGREEMENT

THIS HOME EQUITY LINE MORTGAGE EXTENSION AGREEMENT made and entered into as of the 1st day of June, 1993, by and between ANDERSON REED, SR. A MARRIED MAN ("Borrower"), and ASSOCIATED BANK, FORMERLY KNOWN AS THE CHICAGO BANK OF COMMERCE, an Illinois Banking Association ("Lender")

WITNESSETH That:

Borrower has executed and delivered an Associated Bank Home Equity Line of Credit Mortgage (the "Mortgage") dated April 11, 1988 with a credit limit of \$40,000.00 encumbering certain real property (the "Property") in Cook County, Illinois which Mortgage was recorded on April 22, 1988 as Document Number 88168513 in the Office of the Recorder of Deeds, Cook County, Illinois.

The Property is legally described as follows:

LOT 31 IN BLOCK 5 IN LEE'S SUBDIVISION OF THE WEST 1/2 OF THE SOUTH 1/4 OF SECTION 20, TOWNSHIP 38 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS

Lender is the current holder of the Mortgage and is the Mortgagee under the Mortgage.

AND

Borrower has requested that Lender extend the term of the loan and Lender is willing to do so provided Borrower execute an Amendment to the Mortgage and such further documents as Lender may require, and that the original Mortgage is modified in the manner hereinafter set forth, subject to the terms, provisions and conditions hereinafter contained.

In consideration of the foregoing and of the mutual covenants herein contained, the parties hereby agree as follows:

1. The paragraph entitled "Shall be due and payable" on the first page of the Mortgage is hereby amended by deleting the original maturity date of June 1, 1993 and replacing it with a maturity date of June 1, 1998.
2. This Extension Agreement shall not be construed in any way as a waiver of any of Lender's rights under the Mortgage.
3. In all other respects except as modified herein, the Home Equity Line of Credit Note, Mortgage and all related documents remain unmodified and in full force and effect.

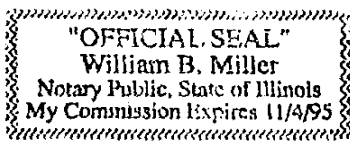

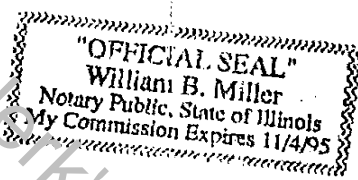

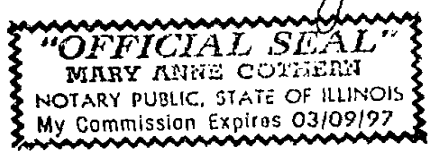
