That said contractor is entitled to credits on account thereof as follows: -0-

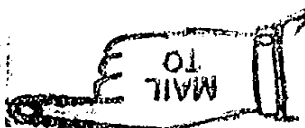

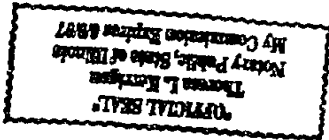
