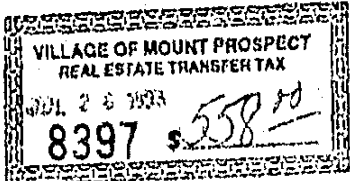
This Indenture, Made this 19th day of July A.D. 19 93 between
