Cepek's Arlington Highlands, being a subdivision of parts of Section 4 and 9, Township 41 North, Range 11 East of the Third Principal Meridian, and parts of Section 31 and 32, Township 42 North, Range 11 East of the Third Principal Meridian, in Cook County, Illinois, according to the plat thereof registered in the Office of the Registrar of Titles, January 26, 1926 as document 288597, described as follows:

Commencing at the Southeast corner of said Lot 185; thence on an assumed bearing of South 89 degrees 33 minutes 21 seconds West along the south line of said Lot 185 a distance of 8.00 feet to a point 8.00 feet normally distant West of the east line of said Lot 185, being also the point of beginning; thence North 0 degree 09 minutes 57 seconds East along a line 8.00 feet normally distant West and parallel with the east line of said Lots 185 and 186 a distance of 119.92 feet to the north line of said Lot 186; thence South 89 degrees 33 minutes 16 seconds West along the said north line of Lot 186 a distance of 5.00 feet to a point 13.00 feet normally distant West of the east line of said Lot 186; thence South 0 degree 09 minutes 57 seconds West along a line 13.00 feet normally distant West and parallel with the east line of said Lots 186 and 185 a distance of 119.92 feet to the south line of said Lot 185; thence North 89 degrees 33 minutes 21 seconds East along the said south line of Lot 185 a distance of 5.00 feet point of beginning.




