leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$1,962.34 Dollars, for which, with interest,

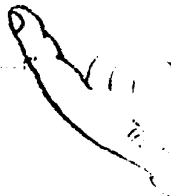

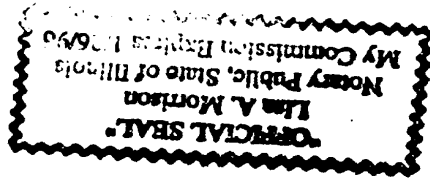

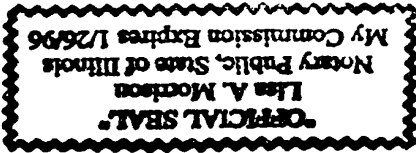
