### MORTGAGE, ASSIGNMENT OF RENTS AND SECURITY AGREEMENT

### WITNESSETH:

WHEREAS, the Martagor is justly indebted to the Mortgagee in the principal sum of Four Hundred Fifty Four Thousand Six Hundred Twenty One Dollars (3454,621.00), as evidenced by a certain Mortgage Note of even date herewith executed by the Mortgagor and made payable to the order of and delivered to the Mortgagee which is due and payable on May 1, 1988, whereby the Mortgagor promises to pay the said principal sum, together with interest thereon, as set forth therein (the "Note").

WHEREAS, the Mortgagee multiple the execution and delivery of certain documents and instruments by the Mortgagor and, if Mortgagor is a land trustee, by the cereficiary(s) of the land trust ("Beneficiary") and by any guarantor of the Note and Loan Documents ("Guarantor") as a part of this los a transaction, each of which may be individually referred to as a "Loan Document" or collectively referred to as the "Loan Documents".

WHEREAS, the Mortgagee requires that the Mortgagor execute and deliver this Mortgage to secure the payment and performance of the obligations and duties of the Mortgagor or any Beneficiary or Quarantor under the Note and all other Loan Documents executed by or on behalf of the Mortgagor, or any Charantor or Beneficiary.

WHEREAS, all of the Loan Documents, including such of their provisions, are incorporated herein by this reference and made a part hereof as though fully set out in this Mortgage.

IN CONSIDERATION OF THE MORTGAGEE MAKING THE LOAN EVIDENCED BY THE NOTE, THE MORTGAGOR ON ITS OWN BEHALF AND ON BEHALF OF ANY BENEFICIARY OR GUARANTOR REPRESENTS, WARRANTS, COVENANTS AND AGREES WITH THE MORTGAGEE AS FOLLOWS:

- 1. Payment of Principal and Interest. The Mortgagor is pledging the Premises to secure the prompt payment, when and as due and payable, of the Indebtedness Secured Hereby.
- 2. Taxes and Other Charges. The Mortgagor shall comply with the following requirements for taxes and other charges:
  - a. Payment. The Mortgagor shall pay, when first due and owing, all general taxes, special taxes, special assessments, water charges, sewer service charges, association charges, and all other charges of whatever kind, ordinary

or extraordinary, whether public or private, which may be levied or imposed against the Premises, and shall furnish to the Mortgages original, official receipts therefor within ten (10) days after payment thereof. The Mortgagor shall also pay when due all charges incurred for the benefit of the Premises for utilities, including energy, fuel, gas, electricity, water, sewer, and garbage removal, whether or not such charges are liens against the Premises.

- from time to time in writing appoint, and in the absence of such appointment, then at the office of the Mortgagee, commencing on the first day of the first month after the date of this Mortgage, and on the first day of each month thereafter until the Indebtedness Secured Hereby is fully paid, and all other obligations secured by this Mortgage are fully discharged, a sum equal to one-twelfth of the last total annual taxes and assessments for the last ascertainable year (general and special) on the Premises (unless said taxes are based upon assessments which exclude the Improvements or any part thereof now constructed, or to be constructed, in which event the amount of such deposits shall be based upon the Mortgagee's estimate as to the amount of taxes and assessments to be levied and assessed). In addition, unless otherwise agreed by the Mortgagee in writing, the Mortgager shall, concurrently with the making of the aforesaid deposit, also deposit with the Mortgagee an amount, based upon the taxes and assessments so ascertainable or so estimated by the Mortgagee, as the case may be, for taxes and assessments on the Premises, on an accrual basis, for the period from January 1 of the year of the first disbursement of the loan proceeds evidenced by the Note to and including the date of the first dispursement of the loan proceeds evidenced by the Note to and including the date of the first deposit required in this subparagraph. Such deposits are (i) to be held without any allowance of interest and need not to be kept separate and apart, (ii) pledged by Mortgagor to Mortgage as additional collateral security, and (iii) are to be used for the payment of taxes and assessments (general and special) for any year when the same shall become due and payable, the Mortgagor shall, within ten (10) days after receipt of demand therefor, deposit as additional funds as may be necessary to pay such taxes and assessments (general and special) for any year, the excess shall be applied on subsequent deposit or deposits.
- 3. Title Policy, Survey and Appraisal. Unless otherwise agreed by the Mortgagee in writing, the Mortgagee shall furnish to the Mortgagee the following, all communications which must be satisfactory to the Mortgagee and the Mortgagee's counsel in form and content:
  - a. An ALTA Loan Indice issued by a title insurance company satisfactory to the Mortgagee and effective prior to any disbursement by and insuring the Mortgagee in the full amount of the Note, insuring the Mortgage to be a valid, prior and paramount lien upon the fee title to the Real Estate subject only to exceptions acceptable to the Mortgagee. The title insurance policy must specifically incorp the Mortgagee for such matters as the Mortgagee may require.
  - b. An ALTA plat of survey ("Survey") (if the Real Estate made by a registered Illinois land surveyor. The Survey shall bear a certificate by the surveyor which shall recite compliance with the ALTA standards, shall include the legal description of the Real Estate and shall be certified to the Mortgagee and the title insurance company. The Mortgager shall furnish supplemental surveys showing adoptional improvements placed on the Real Estate from time to time as required by the Mortgagee.

  - 4. Insurance. The Mortgagor shall comply with the following insurance provisions:
  - Casualty. The Mortgagor shall keep the Improvements now a string or hereafter erected on the Real Estate, all property (whether real, personal or mixed) incorporated therein and all inclorials and supplies delivered to the Premises for use in connection with the construction of any Improvements, together with all equipment used for that purpose, constantly insured against loss or damage under such types and forms of insurunce policies and in such amounts and for such periods as the Mortgagee may from time to time require, and the Mortgagor skill pay promptly, when due, any premiums on such insurance. Unless the Mortgagee otherwise agrees, all such insurance small provide "all risk" coverage and shall be carried with companies acceptable to the Mortgagee and shall have attacked thereto standard noncontributing mortgage clauses in favor of the Mortgagee, as well as standard waiver of subject endorsements. The improvements and all such property, materials, supplies and equipment shall be insured to an e-no int equal to one hundred percent (100%) of the full insurable value thereof (but in no event less than actual replacement, value without deduction for depreciation) at all times against loss or damage by fire, lightning, wind storm, explosion, not and civil commotion, vandalism and malicious mischief, theft and such other risks as are usually included under what leads we known as broad form extended coverage. The Mortgagor shall not carry separate insurance, concurrent in kind or form and contributing in the event of loss, with any insurance required hereunder. In the event of a change of ownership or of occupancy of the Premises (without implying or creating any waiver of the right of approval thereof by the Mortgagee), immediate notice thereof by mail shall be delivered to all insurers. In the event of any loss covered by such insurance, the Mortgagor or any Beneficiary or Guarantor shall immediately notify the Mortgagoe in writing, and the Mortgagor and any Beneficiary or Guarantor hereby authorizes and directs each and every insurance company concerned to make syments for such loss directly and solely to the Mortgagee (which may, but need not, make proof of loss) and the payments for such loss directly and solely to the montgages (which it is discretion all claims under all policies and the Montgages is hereby authorized to adjust, collect, and compromise in its discretion all claims under all policies and the Mortgagor and any Beneficiary or Guarantor shall sign, upon demand by the Mortgagee, all receipts, vouchers, and releases required by such insurance companies. - Preservation, Restoration and Use of Premises. The Mortgagor shall complete, within a reasonable time, any Improvements now or any time in the process of being constructed upon the Real Estate. No Improvement shall (except as required by applicable law) be altered, removed, or demolished nor shall any fixtures, appliances or other personal property subject to the lien hereof, on, in or about the Improvements be severed, removed, sold or mortgaged, without the prior written consent of the Mortgagee, and in the event of the demolition or destruction in whole or in part of any of the fixtures, chattels, or articles of personal property covered hereby or by any separate security agreement given in conjunction herewith, the same shall be replaced promptly by similar fixtures, chattels, and articles of personal property at least equal in quality and condition to those replaced, free from any security interest in or encumbrances thereon or reservation of title thereto. The Mortgagor shall promptly repair, restore,

The Mortgagee is hareby authorized to collect and receive from any governmental or other local authority any and all awards heretofore or hereafter may or to be made to the present and all subsequent owners of the Premises by any such governmental or other lawful authority for the taking, by condemnation or eminent domain (or by threat of condemnation or by settlement of said threat of condemnation), here by assigned from the Mortgagor and any Beneficiary or Cuarantor to the Mortgagor and any Beneficiary or Cuarantor shall give the Mortgagee immediate notice of the actual or threatened commencement of any such proceedings under condemnation or eminent domain, affecting all or any part of the Premises or any easement therein or appurtenance thereof, including severance and consequerual damage and change in grade of streets, and will deliver to the Mortgagee copies of any and all papers served in connection with any such proceedings. The Mortgagor and any Beneficiary or Guarantor shall make, execute and deliver to the Mortgagee at any time or times upon request, free, clear, and discharged of any encumbrances of any kind whatsoever, any and all further assignments and instruments deemed necessary by the Mortgagee for the purpose of validly and sufficiently assigning to the Mortgagee all awards and other compensation heretofore and hereafter to be made to the Mortgagor or any Beneficiary or Guarantor for any taking, eithe, remainent or temporary, under any such proceeding. The proceeds of all such awards shall be paid to the Mortgagee and may be applied by the Mortgagee, at its option, after the payment of all of its expenses in connection with such proceedings, including costs and attorneys' fees, to the reduction of the Indebtedness Secured Hereby or to restoring the Improvements, in which event the later shall be paid out in the same manual as is provided, with respect to insurance proceeds, in the appropriate subparagraph above. - Assignment of Rents and Leases. All rights, powers, entitlements and remedies conferred upon Mortgagee by Mortgagor and any Beneficiary or Guarantor in this paragraph shall apply regardless and independent of whether Mortgagee has commercial proceedings to foreclose this Mortgage. Pursuant to the assignment made by the Mortgagor in the graving clauses of this Mortgage, the Mortgagee is entitled to receive all rents, issues, proceeds, deposits and profits accruing and to acc us from the Premises pursuant to any leases with respect thereto, whether heretofore or hereafter entered into (heromafter referred to as a "lease" or the "leases"). The Mortgagor and any Beneficiary or Guarantor hereby grants and confers upon the Mortgagee the right, power and authority to collect all such rents, issues, proceeds, deposits and profits and the Mortgagor and any Beneficiary or Guarantor appoints the Mortgagee its true and lawful agent and attorney-in-fact, at the option of the Mortgagee, at any time and from time to time, to demand, receive and enforce payment, to give receipts, releases and satisfactions and to sue in the name of the Mortgagor or any Beneficiary or Guarantor, for all such rents, issues, profits, deposits and proceeds accrued but unpaid and in arrears at the date of an event of default hereunder as well as all such rents, issues, profits, deposits and proceeds thereafter accruing and decoming payable during the continuance of any such event of default, and to apply the same to the Indebtedness Secured Hereby; provided, however, that the Mortgagor shall have the right to collect all such rents, issues, profits, deposits and proceeds (but not in advance unless the written approval of the Mortgagee has first been obtained), and to retain and enjoy the same, so long as an Event of Default shall not have occurred or been declared hereunder. In the event any tenant under any of the leases should be the subject of any proceeding under the Federal Bankruptcy Code, as amended from time to time, or any other federal, state or local statute which provides for the possible termination or rejection of such tenant's lease, the Mortgagor covenants and agrees that if any of the leases is so terminated or rejected, no settlement for damages shall be made without the prior written consent of the Mortgagoe and any check in payment of damages for termination or rejection of any such lease will be made psyable both to the Mortgagor and the Mortgagee. The Mortgagor and any Beneficiary or Guarantor hereby assigns any such payment to the Mortgagee and further covenants and agrees that upon the request of the Mortgagee, it will duly endorse to the order of the Mortgagee any such check, the proceeds of which will be applied to whatever portion of the Indebtedness Secured Hereby the Mortgagee may elect.

The Mortgagor of wants and agrees with the Mortgagee that Mortgagor and any Beneficiary or Guarantor shall, without cost, liability or expense to the Mortgagoe: (i) at all times promptly and faithfully abide by, discharge and perform each and every covenant, condition and agreement, each of the leases, on the part of the landlord thereunder to be kept and performed, (ii) enforce or secure the performance of all of the covenants, conditions and agreements of each of the leases on the part of each of the tenants thereunder to be kept and performer, (iii) appear in and defend any action or proceeding arising under, growing out of or in any manner connected with any of the leases or the obligations, duties or liabilities of landlord or of any of the tenants thereunder, and pay all costs and expenses of the Mortgage, including attorneys' fees in any such action or proceeding in which the Mortgage may appear, (iv) transfer and assign to the Mortgage upon request of the Mortgagee, any leases of all or any part of the Premises heretofore or hereafter entered into, and any asset of each and elever to the Mortgagee upon demand, any instruments required to effect such assignment, (v) furnish to the Mortgage, upon request, a written statement containing the name of each and every Lease and the term is of each and every Lease, including the spaces occupied, the rental payable and the security deposits, if any, paid thereunder, (ii) exercise within five (5) days of any demand thereof by the Mortgagee any right to request from a tenant under any of the leases a vertificate with respect to the status thereof, (vii) furnish the Mortgagee under authority hereof, together with interest thereon at the Default Interest Rate provided in the Note and (ix) furnish insurance in accordance with the provisions of the Mortgagee.

The Mortgagor covenants and agrees with the Mortgage t at Mortgagor and any Beneficiary or Guarantor shall not: (i) modify, extend or otherwise alter the terms of any of the leases or any of the guarantees of the leases, (ii) from and after the date hereof execute any lease of all or any portion of the Premises, without mix obtaining the Mortgagee's written consent, which consent may be withheld in the Mortgagee's sole discretion, (iii) in any minnor impair the value of the Premises, (iv) permit any of the leases to become subordinate to any lien other than a lien created by this Assignment, the Mortgage and the Loan Documents, (v) execute an assignment, hypothecation or pledge of any rents of the lease of all or any part of the Premises, except as security for the Indebtedness Secured Hereby, and (vi) accept any prepayment of any installment of rent under any of the leases or all or any portion of the Premises demised thereunder by any tenant under any of the leases.

Upon the occurrence of an Event of Default, and without regard to the adequacy of any other security therefor or whether or not the entire amount of the Indebtedness Secured Hereby is declared to be immediately disc, forthwith, upon demand of the Mortgages, the Mortgages and any Beneficiary or Guarantor shall surrender to the Mortgages and the Mortgages shall be entitled to take actual possession of the Premises, or any part thereof, personally or by its agents or and the Mortgages in its discretion may enter upon and take and maintain possession of all or any part of the Premises, togethe with all documents, books, records, papers and accounts of the Premises, and together with all documents, books, records any Beneficiary or Guarantor or the then manager of the Premises relating thereto, and may reclude the Mortgagor and any Beneficiary or Guarantor, its agents or servants, wholly therefrom and may, as attorney in fact or agent of the Mortgagor and any Beneficiary or Guarantor, or in its own name as the Mortgages and under the powers herein unit discountered in the mortgages.

Any avoids rents, issues and profits of the Premises received by the Mortgagee pursuant hereto shall be applied in payment of or on account of the following, in such order as the Mortgagee may determine: (i) to the payment of the operating expenses of the Premises, including resionable compensation to the Mortgagee or its agent or agents, attorneys' fees and lease commissions and other compensation and entering into leases and the payment of premiums on insurance hereinabove authorized. Should the Mortgages incur any such liability under any of the leases, or under or by reason of this assignment or in defends of any such claims or demands, the amount thereof, including costs, expenses and attorneys' foes, shall be secured hereby and the fortgager and any Beneficiary or Guaranter shall reimburse the Mortgages therefor with interest at the Default Interest Rate provided in the Note immediately upon demand. This assignment shall not operate to place responsibility for the control, care, management or hosts of the Premises upon the Mortgages, nor for the carrying out of any of the terms and conditions of any of the tenants or any other person or for any dangerous or defective conditions of the Premises, or for any negligence in the management, upkeep, topolic or control of the Premises resulting in loss or injury or death to any lesses, inconses, employee or stranger. - 18. Partial lavalidity. However, if any provision or provisions, or if any portion of any provision or provisions, in this Mortgage or the Note is found by a court of law to be in violation of any applicable local, state or federal statute, law, ordinance, rule, regulation or decree, administrative or judicial decision, or public policy, and if such court should declare such portion, provision or provisions of this Mortgage or the Note to be illegal, invalid, unlawful, void or unenforceable as written, then it is the intent both of the Mortgagor and any Beneficiary or Guarantor and the Mortgagee that such portion, provision or provisions shall be given force to the fullest possible extent that it or they are legal, valid and enforceable, that the remainder of this Mortgage and the Note shall be construed as if such illegal, invalid, unlawful, void or unenforceable portion, provision or provisions were not contained herein, or therein, as the case may be, and that the rights, obligations and interest of the Mortgagor and any Beneficiary or Guarantor and the Mortgagee under the remainder of this Mortgage and the Note shall continue in full force and effect. If under the circumstances, interest in excess of the limit allowable by law shall have been paid by the Mortgagor or any Beneficiary or Guarantor in connection with the Indebtedness Secured Hereby, such excess shall be applied by the Mortgagee to the unpaid principal balance of the Note in such manner at the Mortgagor may in its sole discretion determine, or refunded to the Mortgagor in the manner to be determined by the Mortgagor and if any such excess interest has accrued, the Mortgagoe shall eliminate such excess interest so that under no circumstances she interest on the Indebtedness Secured Hereby excess the maximum rate allowed by the law.

- 20. The Mortgage's Right to Deal with Transferee. In the event of the voluntary sale, or transfer by operation of law, or otherwise, of all or any part of the Premises, the Mortgagee is hereby authorized and empowered to deal with such vendee or transferee with reference to the formises, or the Indebtedness Secured Hereby, or with reference to any of the terms or conditions hereof, as fully and to the same extra as it might with the Mortgagor or any Beneficiary or Quarantor, without in any way releasing, or discharging the Mortgagor or any Beneficiary or Quarantor from its covenants and undertakings hereunder, and without the Mortgagee waiving its rights to accelerate the Note.

### 21. Security Agreement.

- a. Mortgage Deemed Security Agreement. Mortgagor, and any Beneficiary or Guarantor, and Mortgagee agree that this Mortgage shall constitute a Security Agreement within the meaning of the Illinois Uniform Commercial Code (hereinafter referred to as the "Code") with respect to (i) all sums at any time on deposit for the benefit of Mortgages or held by the Mortgages (whether seposited by or on behalf of the Mortgagor or anyone else) pursuant to any of the provisions of the Mortgage or the Agreement and (ii) with respect to any personal property included in the granting clauses of this Mortgage, which personal property may not be deemed to be affixed to the Premises or may not constitute a "fixture" (within the meaning of the Code), (which property is hereinafter referred to as "Personal Property") and all replacements of, substitutions for, additions to, any the proceeds thereof (all of said Personal Property and the replacements, substitutions and additions thereto and the proceeds thereof being sometimes hereinafter collectively referred to as the "Collateral"), and that a security interest in and to the Collateral is hereby granted to the Mortgagee, and the Collatoral and all of Mortgagor's, and any Beneficiary's or Guaranto, or right, title and interest therein are hereby assigned to the Mortgagee, all to secure payment of the Indebtedness. All of an provisions contained in this Mortgage pertain and apply to the Collateral as fully and to the same extent as to any other property comprising the Premises; and the following provisions, covenants and warranties shall not limit the applicability of a pother provision of this Mortgage but shall be in addition thereto: (i) Mortgagor, and any Beneficiary or Guarantur (being the Debtor as that term is used in the Code) is and will be the true and lawful owner of the Collateral, subject to no liens charges or encumbrances other than the lien hereof, other liens and encumbrances benefiting Mortgagee and no other party, and lieus and encumbrances, if any, expressly permitted by the Agreement; (ii) the Collateral is to be used by Mortgager, and any Beneficiary or Guarantor, solely for business purposes; (iii) the Collateral will be kept at the Premises, and, except for Cosolete Collateral (as hereinafter defined), will not be removed therefrom without the consent of Mortgages (being the Secured Party as that term is used in the Code) (The Colleteral may be affixed to the Land but will not be affixed to any other re i estate); (iv) the only persons having any interest in the Premises are Mortgagor, and any Beneficiary or Guaranter, Mongages and holders of interests, if any, expressly permitted by the Agreement; and, no Pinancing Statement (other than Pinancing Statements showing Mortgagee as the sole secured party, or with respect to liens or encumbrances, if any, expressly permitted by the Agreement) covering any of the Collateral or any proceeds thereof is on file in any public office except pursuant hereto; and (v) Mortgagor, and any Beneficiary or Guarantor, will at its own cost and expense, upon demand, furnish to Mortgagee such further information and will execute and deliver to Mortgagee such financing statements and other documents in form satisfactory to Mortgagee and will do all such acts as Mortgagee may at any time or from time to time request or as may be necessary or appropriate to establish and maintain a perfected security interest in the Collateral as security for the Indebtedness, subject to no other liens or encumbrances, other than liens or encumbrances benefitting Mortgagee and no other party and liens and encumbrances (if any) expressly permitted by the Agreement; and Mortgagor, and any Beneficiary or Quarantor, will pay the cost of filing or recording such financing statements or other documents, and this instrument, in all public offices wherever filing or recording is deemed by Mortgagee to be desirable.
- b. Remedies Upon Default. Upon Default hereunder, Mortgages shall have the remedies of a secured party under the Code, including without limitation, the right to take immediate and exclusive possession of the Collateral, or any part thereof, and for that purpose may, so far as Mortgager, and any Beneficiary or Quarantor, can give authority therefor, with or without judicial process, enter (if this can be done without breach of the peace), upon any place which the Collateral or any part thereof may be situated and remove the same therefrom (provided that if the Collateral is affixed



to real estate, such removal shall be subject to the conditions stated in the Code); and Mortgagee shall be entitled to hold, maintain, preserve and prepare the Collateral for sale, until disposed of, or may propose to retain the Collateral subject to Mortgagor's, or any Beneficiary's or Guarantor's, right of redemption in satisfaction of Mortgagor's, or any Beneficiary's or Guarantor's, obligations, as provided in the Code. Mortgagee may render the Collateral unusable without removal and may dispose of the Collateral on the Premises. Mortgagee may require Mortgagor, and any Beneficiary or Guarantor, to assemble the Collateral end make it available to Mortgagee for its possession at a place to be designated by Mortgagee which is reasonably convenient to both parties. Mortgagee will give Mortgagor, and any Beneficiary or Guarantor, at least twenty (20) days notice of the time and place of any public sale of the Collateral or of the time after which any private sale or any other intended disposition thereof is made. The requirements of reasonable notice shall be met if such notice is mailed, by certified United States mail or equivalent, postage prepaid, to the address of Mortgagor, and any Beneficiary or Guarantor, hereinafter set forth at least twenty (20) days before the time of the sale or disposition. Mortgagee may buy at any public sale. Mortgagee may buy at private sale if the Collateral is of a type customarily sold in a recognized market or is of a type which is the subject of widely distributed standard price quotations. Any such sale may be held in conjunction with any foreclosure sale of the Premises. If Mortgagee so elects, the Premises and the Collateral may be sold as one lot. The net proceeds realized upon any such disposition, after deduction for the expenses of retaking, holding, preparing for sale, solling and the reasonable attorney's fees and legal expenses incurred by Mortgagee, shall be applied against the Indebtedness in such order or manner as Mortgagee shall select. Mortgagee will accoun

- c Code Applies. The terms and provisions contained in this Article shall, unless the context otherwise requires, have the meanings and be construed as provided in the Code.
- d. Ditended As Financing Statements.
